SECTION-A

INSTRUCTIONS TO BIDDERS

1. PLANT SYNOPSIS

Gujarat Industries Power Company Limited (GIPCL) (henceforth be named Company/GIPCL), is a Premier Power Utility in the State of Gujarat with an installed capacity of 1184.40 MW comprising of various conventional and renewable projects.

GIPCL commissioned its first power project; a 145 MW gas based combined cycle power plant in 1992 at Vadodara. It expanded its capacity 165 MW Naptha and gas based Combined Cycle Power Plant at Vadodara in 1997. GIPCL has commissioned 1MWp Distributed Solar Power Projects at two locations in Gujarat viz. at Village: Amrol, Dist.: Anand and at Village: Vastan, Taluka Mangrol, Dist.: Surat.

Surat Lignite Power Plant (SLPP) with four units of 125 MW capacity each is located at Village: Nani Naroli, Taluka: Mangrol, District: Surat in Gujarat. GIPCL has also operating its own captive Lignite and Lime Stone Mines close to the Power Plant. The Power Plant is based on Circulating Fluidized Bed Combustion (CFBC) technology for the Boilers, where Lignite is burnt along with Lime Stone in the Combustor of the Boiler.

It commissioned 5 MW solar power station at SLPP in 2012. Also, GIPCL has commissioned 1 MW Distributed Solar Power Projects at two locations in Gujarat viz. at Village: Amrol, Dist.: Anand and at Village: Vastan, Taluka Mangrol, Dist.: Surat.

GIPCL has successfully commissioned a 2 x 40 MW Solar Project in 2017 as well as a 75 MW Solar Power Project in 2019 at Gujarat Solar Park, Village Charanka, Dist.: Patan. GIPCL has also successfully commissioned 112.4 MW wind farms at different location of Gujarat and a 100 MW Solar PV project at the Raghanesda Solar Park, Gujarat.

The Company has also been allotted land for development of a 2375 MW Renewable Energy Project at Khavda in Great Rann of Kutch, the Phase 1 of which is being commissioned shortly.

The Company intends to award Bi-Annual Rate Contract for Providing "Integrated Security, Vigilance & Fire Fighting Services for 2375 MW RE Park at Great Rann of Kutch" for a period of Two years and is therefore inviting open tenders online through www.nprocure.com from experienced & resourceful contractors.

2.0 SCOPE OF WORK

The scope of work entails providing comprehensive security, vigilance, and fire safety services at the 2375 MW RE Park located in Khavda, Great Rann of Kutch, Gujarat. The services include security operations, vigilance, firefighting, and the management of security apparatus, with a primary focus on ensuring overall security and fire safety services.

The Contractor will be responsible for all functions related to security, vigilance, and firefighting, as well as any additional duties deemed necessary to enhance the safety and security of the site. The area of services may increase or decrease to any extent depending on the changing requirements of the project.

The Contractor must provide 24/7 security services as directed by the GIPCL (Gujarat Industries Power Company Limited) officials. In the event of any shortage in the number of security guards, it is the Contractor's responsibility to promptly replenish the required security personnel, ensuring that no site or post is left unattended at any time. The Contractor acknowledges that the total number of security staff may vary based on different factors, and they will be required to adjust the manpower accordingly, as directed by GIPCL management with a 24-hour notice.

The Contractor must quote for both the minimum and maximum number of security personnel they can provide on demand within 24 hours, ensuring they can meet GIPCL's security needs as required.

Please refer the detailed scope of work given below: -

Security Services.

2.1 The Contractor shall deploy not less than 50% ex-servicemen security staff (i.e. **Ex- Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel)** having sound physical and mental health. Security Officer cum Fire Officer should be **JCO/Equivalent rank below 55 years of age**, Security Supervisors should be **JCO/NCO/Equivalent below 55 years of age** and Security Guards below **50 years of age**. Ex-servicemen's/ paramilitary personnel's original documents must be submitted to the GIPCL official at the time of initial deployment of each and every security personnel at GIPCL for verification and copy thereof made available for records subsequently.

2.2 It is expected that the contractor deploys 100% ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel) however in exceptional case the remaining strength, i.e. not more than 50% only in Security Guards will be of Smart/good looking, experienced civilian guards with the height not less than 175 Cms. Minimum experience in security duties in Industries should not be less than 5 years. Background check of the civilian guards should be conducted by the Contractor and they should be deployed after proper police verification. It should be clearly understood by the contractor that the civilian guards, if employed will not be kept at par with ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel), the civilian guards, if employed by the contractor will be categorized as unskilled for payment of wages and SoR mentioned in the work order shall also be applicable for payment purpose for unskilled category.

2.3 Out of the total strength of guards being deployed minimum 6 Guards should be qualified drivers and should possess a valid light vehicle driving license. They should be able to drive the Quick Response vehicles and any other company provided or contractor provided vehicles as and when required by the company's designated officials.

2.4 The security personnel deployed by the Contractor should be competent and proficient in handling and operating state of the art CCTV cameras and surveillance equipment. Certificate in this regard will be submitted by the Contractor.

2.5 The Contractor shall protect the GIPCL's property and persons round the clock, and if required, during their commute from residence to the company and vice versa.

2.6 The Contractor shall disallow trespassing of unauthorized persons in the project premises or any other premises belonging to GIPCL.

2.7 The Contractor shall deploy adequate number of persons for effective and efficient services which should include Security officers, Supervisor, Guards, etc., Number of security guards shall be increased or decreased & shall be provided in accordance with the requirement of GIPCL from time to time.

2.8 The Contractor shall depute trained security officers, security supervisors and security guards who are competent in security matters and shall take all measures to prevent any security breaches.

2.9 The Contractor shall be responsible to monitor vehicular traffic at GIPCL gates and inside GIPCL's premises and carry out proper search of GIPCL's employees, laborers, visitors, materials etc., to ensure safety & security of its personnel & property and to prevent illegal exit of GIPCL's property.

2.10 Contractor shall also guide the visitors after completing requisite procedure and perform such other related functions of the security as assigned by the designated official of GIPCL.2.11 The Contractor shall check and verify incoming and outgoing vehicle, equipment and material and monitor loading and unloading of materials in the GIPCL's premises.

2.12 The Security personnel posted must be free from communicable cardiovascular diseases, infections & surgeries. Candidate should not have a past history of mental illness. The nose, ear & throat should be in perfectly fit condition.

2.13 The Physical Fitness Test (PFT) – to determine the physical fitness of a guard following tests shall be conducted – (a) 0.5 Km running (within 3 minutes); (b) Balance Routine; and (c) Parade/Drill. Report of the Physical Fitness Test is to be submitted with physical standards of each candidate as mentioned in the condition of deployment of manpower.

2.14 GIPCL reserves the right to reject any security personnel if not found suitable.

2.15 In case of any abnormal situation sensed/seen by the Contractor's personnel related to security, vigilance and fire at premises of the GIPCL either from an insider or from outside persons (including nearby villages), a regular written report by the Contractor shall be submitted to the GIPCL's Authorized Officer.

2.16 The Contractor shall agree to take additional job assignments and shall deploy sufficient additional security force as & when required by GIPCL during the tenure of the contract. Additional charges shall be payable at mutually agreed rates.

2.17 In case of any theft and loss of property of GIPCL on account of negligence of guards, the same will be reimbursed by the Contractor or alternatively will be adjusted against payments due to the Contractor.

2.18 The Contractor shall be responsible for control and overall supervision of security personnel deployed by him and shall observe all rules and regulations of GIPCL. The security personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

2.19 The Contractor shall be responsible for the completion of the job as defined in this tender and in case he fails to do so; the GIPCL shall recover from the Contractor cost whatsoever incurred for the same.

2.20 The day to day instruction for the work and any clarification regarding specifications for the various items shall be given by the GIPCL's Authorized Officer & his instructions & clarifications/interpretations shall be final & binding to the Contractor.

2.21 The Contractor shall have to engage well-trained and experienced Ex-service man/guards in shifts and after office hours as well as during holidays according to the exigencies of the work. No claim or representation on this account shall be entertained by GIPCL.

2.22 The Contractor shall take full liability of the persons engaged by him. GIPCL reserves the right to deduct any amount legally justified towards any liability not fulfilled by the Contractor.

2.23 It is the responsibility of the Security Agency to protect the Solar park, to ensure that no trespass takes place into company premises and also to ensure that no material is moved out by anyone by any means without authorization, and in case of an incident, same shall be brought to the immediate attention of GIPCL management in writing.

2.24 The Contractor's responsible Officer should take round of the GIPCL's premises during the night hours, at least once in the fortnight and submit the report in writing to the GIPCL's Authorized Officer in morning of the next day.

Fire Safety Role

2.25 The Contractor shall deploy suitably qualified and sufficient manpower for timely & satisfactorily execution of the works under the contract. Qualification of the fire safety staff is prescribed below:

a)	Fire Supervisor	12 th pass,06 months' fireman course with minimum 3
		years of experience, below the age of 55 years
c)	Fire Driver cum Operator	12th pass,06 months' Fireman Course, Valid Heavy
		Vehicle License, minimum 2 years of experience,
		below the age of 50 years.
d)	Fireman	12 th pass,06 months' fireman course with minimum 1
		year of experience, below the age of 45 years.

2.26 The Contractor shall be responsible for all fire safety control and overall supervision of fire safety personnel deployed by him and shall observe all rules and regulations of the GIPCL. The fire safety personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

2.27 The Contractor shall deploy the necessary Fire Fighting Equipment at critical sites as required by the Fire Safety Officer of GIPCL. The Contractor shall also conduct the weekly inspections and replenish any Fire Fighting Equipment found to be faulty, non-functional or empty. The Contractor shall comply with the industrial Fire Fighting Standard Operating Procedures and any failure to comply to the would invite necessary penalties as deemed fit the management of GIPCL.

2.28 Contractor shall be responsible for providing Fire services at GIPCL as per requirement. In the event of any shortfall in the number of fire personnel for any reasons whatsoever it will be contractor's responsibility to replenish the requisite number of fire personnel and ensure that at no time post will be left unattended.

2.29 It must be clearly understood by the contractor that the total strength of the fire personnel may be differing depending upon various factors. Contractor will reduce or increase strength as required after consulting head of Fire/Fire department, GIPCL.

2.30 Fire personnel deployed at site by contractor must be well trained and motivated, smartly dressed and have a disciplined conduct expected of Firemen. The fire personnel shall not be found drunken or under influence of drugs while they are on duty. They should be physically and mentally sound with good eye sight.

2.31 The contractor shall be responsible for overall administration and discipline of the security and fire personnel deployed by him as well as for maintenance of equipment required for efficient performance of duties as per the scope of work and maintain good housekeeping as required by company.

2.32 The security and fire personnel so provided shall be contractor's employees, wholly under contractor's direct administrative control and supervision and contractor will be held solely responsible to take disciplinary action against them if they indulge in any act of misconduct within the premises of the GIPCL or outside during the tenure of the contract.

2.33 Adequate reserve for security and fire personnel will be maintained for providing weekly off to security and fire personnel.

2.34 Any shortfall in strength may attract Rs.500/- per day. Decision of head of Security/Fire department will be final in this matter.

2.35 Contractor will ensure that payment is made to his security & fire staff by 7th of every month. The penalty up to Rs.500/- per day for each defaulted day may be imposed.

2.36 Any lapses/ violations by the contractor of any of the terms and conditions, general and statutory requirements as specified in this bid will be penalized by GIPCL. Defaults like vacant Post/ indiscipline/ sleeping on duty/ intoxication etc. committed by the security & fire personnel will invite appropriate punitive measures as decided by competent authority of GIPCL.

2.37 GIPCL reserves the right to increase and/ or decrease and also to change the norms regarding deployment of Fire personnel due to exigencies of prevailing conditions with a written notice of 07 (seven) days, without giving any reasons. Payment to the contractor will be made as per actual duty

performed and number of security & fire personnel deployed in a month and as per quoted rates.

2.38 At the time of deploying manpower, the Contractor shall strictly comply all the applicable labour laws/Acts norms including but not restricted to the age of the workers, women workers and shall also ensure that a police verification and security check for all the workmen/labour engaged at the GIPCL Site is done and necessary documents regarding the same shall be submitted to the GIPCL's authorized representative/officer-in-charge. Any default in complying with the same or any misrepresentation regarding compliance of the same shall compel GIPCL to initiate appropriate civil or criminal proceedings regarding the same.

2.39 The Contractor shall also comply with the safety requirements and provide his workmen/labour with safety equipment like helmets, masks, gum boots, a uniform (Minimum 03 pairs for AMC/ARC) and other necessary PPEs for properly undertaking the operations involved under this contract. Following are also to be issued by contractor:

• Uniform (Blue) yearly	:	3 Pair (with all accessories)
• Safety shoes (yearly)	:	1 Pair
• Fire Helmet (ISI Marked)	:	1 No.
• Gumboot (Yearly)	:	1 Pair
Goggles / face shield	:	As per requirement.
• Ear plug / Ear muff	:	As per requirement
• Hand gloves like electrical hand	gloves / c	cotton hand gloves / Chemical hand

 Hand gloves like electrical hand gloves / cotton hand gloves / Chemical hand gloves (As per requirement)

2.40 The contractor will issue good quality of uniform and other PPEs as mentioned above within 30 days of taking over the contract, failing which **penalty of Rs.250/-per day per default** will be imposed till issuance of all the PPEs to the entire fireman deployed in the plant.

2.41 Contractor shall nominate /authorize senior experienced person in writing as site in- charge to co-ordinate with GIPCL Security & Fire Officer (in-charge) and who shall bear overall responsibility for performance of the contract. Such person shall remain always available at Site or Site office allotted to the contractor at Site. Contractor has to submit the authority letter and documentary proof for the same.

2.42 The Contractor shall appoint a supervisor who shall co-ordinate with GIPCL Security & Fire Officer (in-charge) for daily entrusted job. They have to maintain daily records dully signed for the works carried out and duly certified by Fire Officer (in-charge).

2.43 The Contractor in co-ordination with the GIPCL Security & Fire Officer (in-charge) shall ensure the availability of adequate manpower to carry out the job satisfactorily on a daily basis.

2.44 Contractor's supervisor will be responsible for complete supervision of the workforce engaged by him. He will be responsible for distribution of the duty posts as per requirement and arrangement for replacement of shortfall of personnel. He will also maintain all relevant records and report regularly as required under rules.

2.45 During emergency or similar situations, the Contractor shall be required to mobilize resources as per need within the period of 24 hours as directed by GIPCL. If the contractor fails to mobilize sufficient manpower to complete the job in time, GIPCL will execute the job through other agency at the risk and cost of the contractor with 10% supervision charges & the same will be recovered from the Contractor's bill.

2.46 *Important Note:* Whenever any of the Unit at Solar Park remains under outage due to any reason attributed to Security & Fire, the contractor shall mobilize sufficient work force at Site within a period of twenty-four hours from the time of intimation to the Site- in-charge or via mail to your office. Generation loss occurred due to want of manpower as well as resources will be viewed very seriously and will invite appropriate punitive measures as decided by competent authority of GIPCL.

2.47 During working in high risk area like the workman must wear a suitable safety apron, safety belt, safety hand gloves and goggles. It is the contractor's/contractor's supervisor's responsibility to ensure it without fail.

2.48 In case of fire or any other emergency or if Company receives call from OCR (Off Site Industrial Emergency Control Room) or any other Central Control and Monitoring Room, Contractor shall attend to the emergency and assist the fire crew or emergency service personnel as per the instruction of GIPCL's Authorized Officer.

2.49 All the miscellaneous activities pertaining to specific work to be executed for satisfactory performance is in the scope of Contractor in his quoted rates.

Accommodation, Food, Transportation & Miscellaneous.

2.50 The Contractor shall be responsible to make necessary arrangement for accommodation, messing, medical facility, seasonal comfort items as per the prevailing weather conditions, stationery, security equipment, uniform, accessories, sticks, torches, motorcycles for patrolling duties and any other equipment on the site of deployment and discharge of duty needed by the security and fire safety personnel for effective discharge of their duties.

2.51 The contractor shall be responsible for providing adequate and necessary means of transportation for transporting the security and fire safety manpower to and from their place of residence to the duty station. The contractor shall also deploy suitable vehicle/vehicles for carrying out night patrolling and ensuring the security of the assets in the park and ensuring that no perimeter breach takes place.

3. <u>GENERAL INSTRUCTIONS</u>

3.1 The Bidders who are interested in participating in the tender must read and comply with the instructions and the Terms & Conditions contained in the tender documents.

3.2 The Bids shall be filled in by the Bidders clearly, neatly and accurately. Any alteration, erasures or overwriting shall be liable to make the tender invalid unless the same is neatly carried out and attested over the full signature of Bidder. The decision of the Company to interpret the information and rates filled in by the Bidder shall be final and binding on the Bidder.

3.3 The Bidders are requested to make themselves fully conversant with the General Conditions of Contract, Special Conditions of Contract, Technical Specifications, Site conditions, Safety & Health Aspects and Norms to be observed etc. before submitting their bids so that no ambiguity arises in these respects subsequent to submission of the Bids.

3.4 Before quoting the rates, the Bidder must visit Site and should go through the specifications, scope of work etc. and get himself fully conversant with them. The Bid should include cost of mobilization and cost to adhere to all Safety Norms as described in the tender. No relaxation or request for revision of quoted/accepted rates shall be entertained subsequent to the opening of Bid on account of mobilization or Safety costs.

3.5 Bidder has to submit all the information as per required Bid document. Failure to furnish all the information as per required Bid documents or submission of a Bid containing deviations from the contractual terms and conditions, specifications and requirements, shall be rejected.

3.6 The Bids shall be submitted within the time frames set out in the Notice Inviting Tender ('NIT') and Bids submitted thereafter shall not be accepted and shall not be considered.

3.7 The tender documents shall not be transferable.

3.8 The Bidders are expected to examine all instructions, forms, terms & specifications in the Bid documents and to get fully acquainted themselves with all the conditions and matters which may affect the subject matter of the work/tender or the cost thereof. If any Bidder finds any discrepancies or omissions in the specifications and documents or any doubt in true meaning or interpretation of any part, he shall seek necessary clarifications in writing, if required.

3.9 Conditional offers shall not be considered and same is liable to be rejected.

3.10 The Company reserves the right to extend the deadlines for submission of the Bids by giving amendments.

3.11 During evaluation of Bids the Company may, at its discretion, ask the Bidder (s) for clarification of their Bid. The request for clarification and the response shall be in writing and no change in prices or substance of the Bid shall be sought, offered or permitted.

3.12 The Company reserves the right to amend/ modify the Bidding documents at any time prior to the deadline for submission of Bids, either at its own discretion or in response to the clarification requested by a prospective Bidder. In such case, the Company may in its discretion extend the deadline for submission of Bids in order to facilitate the prospective Bidders for incorporating the effect of the amendment in their Bids.

3.13 The Bidders shall bear all costs and expenses associated with the preparation and submission of their respective Bids, to attend meetings or conferences, if any, including any pre-award discussion with the successful Bidder, technical and other presentations etc. and the Company shall not be liable for any expense thereof.

3.14 If the successful Bidder is consortium/joint deed of undertaking of company, the Consortium leader/Bidder shall accept joint and several responsibilities and liabilities for all obligations under the Contract.

3.15 Timely and satisfactory completion of the work and strict adherence to the allotted time frames for jobs shall be the essence of the contract.

3.16 GIPCL reserves the right to qualify/disqualify any applicant without assigning any reason.

3.17 The Bidder shall be disqualified if any untrue statement or misrepresentation is made in the Bid forms, attachments and other supporting documents submitted by the Bidder.

4. <u>PLANT VISIT</u>

4.1 It is perquisite and necessary for all interested Bidders to visit the Site/plant after downloading the tender copy to understand the actual working conditions, compliance related to labour, safety etc. before submitting their offer. Failing which, any consequential liabilities arising will be to Bidder's account. The Bidders shall examine the Site of work and its surroundings at his own responsibility. The Bidders shall collect information that may be necessary for preparing the bid and entering into a contract. All costs and liabilities arising out of the Site visit shall be at Bidder's account.

4.2 The Bidder is deemed to have examined and understood the tender document, obtained his own information in all matters whatsoever that might affect the carrying out the works expressly mentioned or works which may have to be carried out to fulfil his contractual obligation within the scheduled rates and to have satisfied himself to the sufficiency for his offer

4.3 The submission of tender by a Bidder implies that he has visited the Site and read these instructions, conditions of the contract etc. and has himself aware of the scope, nature of works & specifications of the works to be done, General & Special Terms and Condition. GIPCL will not, therefore after acceptance of Bidder's rate, pay any extra charges for any other reason in case the Bidder is found later on to have misjudged the Site conditions.

4.4 Any error in description or quantity or omission in the contract document shall not vitiate the contract or release the Bidder from executing the work comprised in the contract according to scope of works, magnitude of the works, requirement of materials, equipment, tools& tackles, workforce, etc. Bidder has to complete the work in accordance with the contract documents irrespective of any defects, omissions or errors that may be found in the contract documents.

4.5 BIDDER shall inspect the Site, examine and obtain all information required and satisfy himself regarding matters such as access to Site, communication, transport, working condition including constraint of work place, confined area, quantum of dusting, running equipment, importance of work, round the clock working conditions, safety requirements, associated risks, right of way, high flood level in River, flow of water during monsoon/dry season in the River/Nallah, the type and number of equipment and facilities required for the satisfactory completion of work, the quantity of various items of the work, the availability of manpower at Site, availability and rates of material, local working conditions, uncertainties of weather, obstructions and hindrances that may arise, etc which may affect the work or cost thereof, before submission of his Bid. Ignorance of Site conditions shall not be accepted by GIPCL as basis for any claim for compensation. The submission of a Bid by the Bidder will be construed as evidence that such an examination was made. Any later claims / disputes in regard to rates quoted shall not be entertained or considered by the GIPCL.

4.6 The rates quoted by Bidder shall be based on his own knowledge and judgment of the conditions and hazards involved and shall not be based on any representations of the employee(s) of the company.

5. ELIGIBILITY CRITERIA

The following criteria shall be adopted for qualifying the Bidders for further proceeding.

5.1 Bidder should possess minimum Three years of experience during last five years in similar nature job in power plants / process industries/ Renewable Parks/Corporate Parks/Industrial Parks. Bidder shall submit necessary evidence for the same like attested copies of work orders/work completion certificates from clients where the work was completed. The work completion certificate shall comprise of Order value & Executed value. Bidders should have executed the work directly. The work executed as a sub-Bidder or subletting agency shall not be taken in to consideration.

5.2 Bidder should produce evidence of having experience of successfully completed similar works as defined hereunder during last five years ending on last day of the month previous to the one in which tender is invited, satisfactory progress of ongoing works etc. secured from clients along with self-attested copies of documentary evidence preferably photo copies of work experience. The experience should be either of the following:

One similar completed/executed work each costing not less than the amount equal to Rs. 97.5 Lacs.

OR

Two similar completed/executed works each costing not less than the amount equal to Rs. 65 Lacs.

OR

Three similar completed/executed works each costing not less than the amount equal to Rs. 49 Lacs.

Bidder should specifically mention fulfilling of above criteria in his offer along with details of work orders & work completion/execution certificates issued by clients.

5.3 Tender fee: The **Tender Fee of Rs. 2950.00**/- Rupees Two thousand Nine Hundred and Fifty only) shall be accompanied in form of RTGS.

5.4 EMD: The EMD of Rs. 1,22,000/- (Rupees One Lakh Twenty-Two Thousand only) shall be accompanied in the form of DD/RTGS or Bank Guarantee given by Bank as described in subsequent clause no. 7.

5.5 Bidder should have separate Employees Provident Fund code number towards registration of firm with RPF commissioner.

5.6 Attested copies of relevant documents duly signed & sealed on each & every page shall be submitted. GIPCL may verify the documents, experience certificates issued by concern authority. After opening of technical Bid, if any required attested documents are found missing in the Technical Bid submitted by the Bidder, the tender inviting authority may inform to that Bidder by E-mail to submit the missing required documents within stipulated time limit. If Bidder/Bidders fail to submit them within stipulated time, their Bid will be declared technically disqualified and no further correspondence will be entertained.

5.7 Bidder should have average annual turnover of Rs.48.71 lacs (calculated to be 30% of the estimated annualized contract value) for each of last three financial. Bidder shall furnish annual audited financial statement duly certified by a qualified Chartered Accountant for the last three financial years to demonstrate the financial healthiness of the company. The Balance Sheet and Profit & Loss Account must be in the name of the company. Any type of MOU for this purpose will not be entertained.

Note: In case, the annual turnover is less than the statutory guideline which does not require audit, the Bidder shall submit **the turnover certificate** from a Chartered Accountant.

5.8 The Bidder has to submit INCOME TAX Permanent Account Number (PAN), & GST registration number. Copies of the same shall be submitted.

5.9 The net worth of the Bidder should be positive as evidenced from audited accounts of last financial year.

5.10 In case Bidder is a Consortium/Joint deed of undertaking of company, the above requirements/credential of consortium leader/Bidder shall be considered unless otherwise specifically mentioned in the tender.

5.11 If Bidder or its Partner(s) or Director(s) is /are/was Black Listed / Deregistered / Stopped or banned from dealing in the past by any Govt, of Gujarat Undertakings / Depts. / Authorities and Govt. of Gujarat supported companies / undertakings / organizations, Bid of that party may be liable to be rejected. Bidder agrees and undertakes to accept decision of GIPCL in this regard as final and binding on the Bidder without any demur and that no further correspondence shall be done in this regard at any stage. Bidder shall have to submit "Declaration for Contractual Litigations" as amended in Annexure / Form attached.

5.12 The Bidder should have minimum 25 ex-servicemen working under their payroll. A proof in this regard should be produced, along with technical bid. Before awarding the contract, it will be ensured that the agency is having the capacity to post required ex-serviceman for security duties. Work Order & performance certificates from 3 different clients where more than 25 ESM guards have been provided should be furnished.

5.13 Bidder shall have to submit the "Declaration-cum-Undertaking for Compliance of Safety Laws and Regulations" as amended in Annexure / Form attached.

If any Major Violation of any safety law(s) / Rule(s) is / are found during the preceding Three (3) years, Bid of that party will be liable to be rejected. Bidder agrees and undertakes to accept decision of GIPCL in this regard as final and binding on the Bidder without any demur and that no further correspondence shall be done in this regard at any stage.

If any of the details submitted in the prescribed Annexure / Form to the Bid is/are found to be false, incorrect at any time in future, then the Contract awarded to that Bidder / Bidder shall be liable to be terminated forthwith without any notice / correspondence and Bidder agrees and undertakes to accept decision of GIPCL in this regards as final and binding on the Bidder without any demur and that no further correspondence shall be done in this regard at any stage. Further, Performance / Security Deposit will also be liable to be forfeited. Any dues to GIPCL from the Bidder / Bidder shall be recovered from the pending bills or any other dues payable to the Bidder / Bidder, if any or otherwise through any other recourse available under the Laws.

The Bidder shall submit all the evidences, documents, attested copies of work orders & work completion certificates etc. as a proof with EMD &Tender Fee and also provide the requisite details online for meeting the prequalification requirements. GIPCL will verify the experience, performance, capability & strength of Bidders, independently for executing the job. GIPCL may visit the Site & consult the owner of the industry/property where similar job is executed by the Bidder. GIPCL reserves the right to accept/cancel/reject any/all Bids without assigning any reason thereof. The tenders of qualified Bidder/Bidders shall only be considered for further evaluation.

6. LANGUAGE OF BID

The Bid prepared by the Bidder, and all correspondence and documents relating to the Bid exchanged by the Bidder and the Company, shall be written in the English language. Any printed literature furnished by the Bidder, written in another language shall be accompanied by an English translation for the purpose of interpretation of the Bid.

7. EARNEST MONEY DEPOSIT (EMD) and TENDER FEE

7.1 An EMD of Rs. 1,22,000/- (Rupees One Lakh Twenty Two Thousand only) and Nonrefundable Tender fee Rs. 2950/- shall accompany with Bid. Tender fee shall be submitted through on-line mode only while EMD shall be submitted through RTGS / on line mode/ in the form of a crossed bank Demand Draft in favor of Gujarat Industries Power Co. Ltd. only.

7.7 No interest shall be payable on EMD.

8. SUBMISSION OF BIDS

A: MODE OF SUBMISSION

The bids shall be submitted online at the e-portal system within the dates specified in the NIT along with the details of Tender Fee, EMD in two parts as under:

- (a) Pre-qualification and Techno-commercial Bid without price.
- (b) Price Bid.

(a) Pre-qualification and Techno-commercial Bid without price:

The tender document duly signed in all pages without price bid along with Techno commercial deviations, if any, shall accompany the bid. The following Information shall be provided in the techno commercial bid:

- (i) The Bid must contain the postal address like name, residence and place of business of the person or persons submitting the Bid and must be signed and sealed by the Bidder with his usual signature. The name of all persons signing the documents shall also be typed or printed below the signature on each page.
- (ii) Bid by a consortium/joint deed of undertaking of company/partnership firm must be furnished with full names of all partners and be signed with the partnership name, followed by the signature and designation of one of the authorized partners or other authorized representative(s). A certified copy of the power of attorney authorizing such partner or representative shall also be submitted.

The submission of any Bid along with the required documents and specifications shall constitute an agreement that the Bidder shall have no cause of action or claim, against the Company for rejection of his Bid. The Company shall always be at liberty to reject or accept any Bid or Bids at his sole discretion and any action will not be called into question and the Bidder shall have no claim in that regard against the GIPCL.

12. <u>OPENING OF BIDS</u>

12.1 The GIPCL will open the pre-qualification/Technical Bid/price Bid, as the case may be, in presence of Bidder's representatives whenever such a procedure has been specified. Otherwise the tender will be opened by the authorized officers of GIPCL.

12.2 Preliminary Examination:

12.2.1 The Company will examine the Bids for any computational errors, for sureties furnished by Bidder, for authentication of documents submitted and completeness of the Bids.

12.2.2 Arithmetical errors will be rectified on the following basis:

(a) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price will be corrected & will be binding to the Bidders

(b) If there is a discrepancy between the Total Bid Amount and the sum of total prices, the sum of total prices shall prevail and the Total Bid Amount will be corrected & will be binding to the Bidders.

13. EVALUATION & COMPARISON OF BIDS

13.1 GIPCL shall evaluate the Bids received and accepted by it to ascertain the lowest evaluated Bid in conformity with the specifications of the tender documents.

13.2 The Technical Bids will be examined for minor matters regarding qualification of bids. Subsequent to correspondence with the respective Bidders, the decision of Tender Committee will be final.

13.3 All responses to requests for clarifications shall be in writing and shall be presented to the Company through e-mail or in a sealed envelope on or before the given date requested by the Company. If the Technical clarifications sought by the Company do not reach the Company on or before due date, the Bid will be rejected.

13.4 The comparison of all the Bids shall be carried out with reference to the scope of work as per the technical specification. Any deviation/omission shall be evaluated at highest quoted price of the deviation/omission quoted by any of the Bidder. In case a separate price (for omission) is not given by any other Bidder, a reasonable price of the same shall be taken & the same shall be binding to the Bidders.

13.5 The commercial deviation, if any, shall be loaded to bring all the Bids at par. The loading shall

be carried out at an interest rate of 2% above PLR of SBI.

13.6 A Bid to be substantially responsive shall be one which on evaluation confirms to all the terms, conditions and specifications of the Bid documents without any material deviation or reservation.

13.7 For the above referred purpose, a 'material deviation' shall be one:

- (a) Which affects in any substantial way the scope, quality or performance of the contract, or
- (b) Which limits in any substantial way and in a manner inconsistent with the Bid documents, GIPCL's right or the Bidder's obligations, under the contract, or
- (c) Whose rectification would affect unfairly the competitive position of other Bidders presenting substantially responsive bids.

14. <u>RIGHT OF REJECTION OF TENDERS</u>

14.1 GIPCL reserves the right to accept or reject any Bid or to cancel the Bidding process and reject all Bids at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders regarding the same.

14.2 Any Tender without EMD and/or Tender fee will be treated as non-responsive and shall be rejected at the outset & no further correspondence shall be entertained regarding this.

14.3 GIPCL reserves the right to debar any Bidder from participation in future Bids if such Bidder has quoted an abnormally low rate in the Bid document/price Bid.

15. <u>AWARD OF CONTRACT</u>

15.1 GIPCL will award the contract to that Bidder whose quotation has been determined to be substantially responsive and evaluated as the lowest quotation in conformity with the requirements of the specifications and documents contained herein, provided further that the Bidder is determined and evaluated to be qualified to perform the contract satisfactorily.

15.2 The successful Bidder shall be intimated of his selection through the Letter of Intent or Letter of Award/ Work Order which shall be sent to him through e-mail, courier, fax or registered mail.

15.3 GIPCL reserves the right to cancel/short close the contract during the contract period without assigning any reason.

15.4 GIPCL reserves the right to split the contract quantity between vendors.

16. <u>CONTRACT PERIOD</u>

16.1 The contract will be for a **period of 02 years** from the date of actual commencement of operation of the contract as stated in the Work Order.

16.2 GIPCL reserves the right to extend the Contract Period up to 3 months on the same rates and terms and conditions without any price escalation and without entering into any new contract.

16.3 The said Contract Period can be extended if mutually agreed upon by both the parties up

to one year and in such a case a revised work order shall be **issued at the same rates and terms & condition or at negotiated rates acceptable by both parties i.e. the Company & the Bidder.**

17. ASSIGNMENT AND SUB-LETTING

The Contractor shall not directly or indirectly assign or sub-let total/any part of the contract to any other party or agency.

18. CONTRACTOR'S OBLIGATIONS

Security Services.

18.1 The Contractor shall deploy not less than 50% ex-servicemen security staff (i.e. Ex- Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel) having sound physical and mental health. Security Officer cum Fire Officer should be JCO/Equivalent rank below 55 years of age, Security Supervisors should be JCO/NCO/Equivalent below 55 years of age and Security Guards below 50 years of age. Ex-servicemen's/ paramilitary personnel's original documents must be submitted to the GIPCL official at the time of initial deployment of each and every security personnel at GIPCL for verification and copy thereof made available for records subsequently.

18.2 It is expected that the contractor deploys 100% ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel) however in exceptional case the remaining strength, i.e. not more than 50% only in Security Guards will be of Smart/good looking, experienced civilian guards with the height not less than 175 Cms. Minimum experience in security duties in Industries should not be less than 5 years. Background check of the civilian guards should be conducted by the Contractor and they should be deployed after proper police verification. It should be clearly understood by the contractor that the civilian guards, if employed will not be kept at par with ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel), the civilian guards, if employed by the contractor will be categorized as unskilled for payment of wages and SoR mentioned in the work order shall also be applicable for payment purpose for unskilled category.

18.3 Out of the total strength of guards being deployed minimum 6 Guards should be qualified drivers and should possess a valid light vehicle driving license. They should be able to drive the Quick Response vehicles and any other company provided or contractor provided vehicles as and when required by the company's designated officials.

18.4 The security personnel deployed by the Contractor should be competent and proficient in handling and operating state of the art CCTV cameras and surveillance equipment. Certificate in this regard will be submitted by the Contractor.

18.5 The Contractor shall protect the GIPCL's property and persons round the clock, and if required, during their commute from residence to the company and vice versa.

18.6 The Contractor shall disallow trespassing of unauthorized persons in the Plant or any other premises belonging to GIPCL.

18.7 The Contractor shall deploy adequate number of persons for effective and efficient services which should include Security officers, Supervisor, Guards, etc., Number of security guards shall be

increased or decreased & shall be provided in accordance with the requirement of GIPCL from time to time.

18.8 The Contractor shall depute trained security officers, security supervisors and security guards who are competent in security matters and shall take all measures to prevent any security breaches.

18.9 The Contractor shall be responsible to monitor vehicular traffic at GIPCL gates and inside GIPCL's premises and carry out proper search of GIPCL's employees, laborers, visitors, materials etc., to ensure safety & security of its personnel & property and to prevent illegal exit of GIPCL's property. 18.10 Contractor shall also guide the visitors after completing requisite procedure and perform such other related functions of the security as assigned by the designated official of GIPCL.

18.11 The Contractor shall check and verify incoming and outgoing vehicle, equipment and material and monitor loading and unloading of materials in the GIPCL's premises.

18.12 The Security personnel posted must be free from communicable cardiovascular diseases, infections & surgeries. Candidate should not have a past history of mental illness. The nose, ear & throat should be in perfectly fit condition.

18.13 The Physical Fitness Test (PFT) – to determine the physical fitness of a guard following tests shall be conducted – (a) 0.5 Km running (within 3 minutes); (b) Balance Routine; and (c) Parade/Drill. Report of the Physical Fitness Test is to be submitted with physical standards of each candidate as mentioned in the condition of deployment of manpower.

18.14 GIPCL reserves the right to reject any security personnel if not found suitable.

18.15 In case of any abnormal situation sensed/seen by the Contractor's personnel related to security, vigilance and fire at premises of the GIPCL either from an insider or from outside persons (including nearby villages), a regular written report by the Contractor shall be submitted to the GIPCL's Authorized Officer.

18.16 The Contractor shall agree to take additional job assignments and shall deploy sufficient additional security force as & when required by GIPCL during the tenure of the contract. Additional charges shall be payable at mutually agreed rates.

18.17 In case of any theft and loss of property of GIPCL on account of negligence of guards, the same will be reimbursed by the Contractor or alternatively will be adjusted against payments due to the Contractor.

18.18 The Contractor shall be responsible for control and overall supervision of security personnel deployed by him and shall observe all rules and regulations of the GIPCL. The security personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

18.19 The Contractor shall be responsible for the completion of the job as defined in this tender and in case he fails to do so; the GIPCL shall recover from the Contractor cost whatsoever incurred for the same.

18.20 The day to day instruction for the work and any clarification regarding specifications for the various items shall be given by the GIPCL's Authorized Officer & his instructions & clarifications/interpretations shall be final & binding to the Contractor.

18.21 The Contractor shall have to engage well-trained and experienced Ex-service man/guards in shifts and after office hours as well as during holidays according to the exigencies of the work. No claim or representation on this account shall be entertained by GIPCL.

18.22 The Contractor shall take full liability of the persons engaged by him. GIPCL reserves the right to deduct any amount legally justified towards any liability not fulfilled by the Contractor. I

18.23 It is the responsibility of the Security Agency to protect the Solar park, to ensure that no trespass takes place into company premises and also to ensure that no material is moved out by anyone by any means without authorization, and in case of an incident, same shall be brought to the immediate attention of GIPCL management in writing.

18.24 The Contractor's responsible Officer should take round of the GIPCL's premises during the night hours, at least once in the fortnight and submit the report in writing to the GIPCL's Authorized Officer in morning of the next day.

Fire Safety Role

18.25 The Contractor shall deploy suitably qualified and sufficient manpower for timely & satisfactorily execution of the works under the contract. Qualification of the fire safety staff is prescribed below:

a)	Fire Supervisor	12 th pass,06 months' fireman course with minimum 3 years of experience, below the age of 55 years
c)	Fire Driver cum Operator	12 th pass,06 months' Fireman Course, Valid Heavy Vehicle License, minimum 2 years of experience, below the age of 50 years.
d)	Fireman	12 th pass,06 months' fireman course with minimum 1 year of experience, below the age of 45 years.

18.26 The Contractor shall be responsible for all fire safety control and overall supervision of fire safety personnel deployed by him and shall observe all rules and regulations of the GIPCL. The fire safety personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

18.27 The Contractor shall deploy the necessary Fire Fighting Equipment at critical Sites as required by the Fire Safety Officer of GIPCL. The Contractor shall also conduct the weekly inspections and replenish any Fire Fighting Equipment found to be faulty, non-functional or empty. The Contractor shall comply with the industrial Fire Fighting Standard Operating Procedures and any failure to comply to the would invite necessary penalties as deemed fit the management of GIPCL.

18.28 Contractor shall be responsible for providing Fire services at GIPCL as per requirement. In the event of any shortfall in the number of fire personnel for any reasons whatsoever it will be contractor's responsibility to replenish the requisite number of fire personnel and ensure that at no time post will be left unattended.

18.29 It must be clearly understood by the contractor that the total strength of the fire personnel may be differing depending upon various factors. Contractor will reduce or increase strength as required after consulting head of Fire/Fire department, GIPCL.

18.30 Fire personnel deployed at Site by contractor must be well trained and motivated, smartly dressed and have a disciplined conduct expected of Firemen. The fire personnel shall not be found drunken or under influence of drugs while they are on duty. They should be physically and mentally sound with good eye sight.

18.31 The contractor shall be responsible for overall administration and discipline of the security and fire personnel deployed by him as well as for maintenance of equipment required for efficient performance of duties as per the scope of work and maintain good housekeeping as required by company.

18.32 The security and fire personnel so provided shall be contractor's employees, wholly under contractor's direct administrative control and supervision and contractor will be held solely responsible to take disciplinary action against them if they indulge in any act of misconduct within the premises of the GIPCL or outside during the tenure of the contract.

18.33 Adequate reserve for security and fire personnel will be maintained for providing weekly off to security and fire personnel.

18.34 Any shortfall in strength may attract Rs.500/- per day. Decision of head of Security/Fire department will be final in this matter.

18.35 Contractor will ensure that payment is made to his security & fire staff by 7th of every month. The penalty up to Rs.500/- per day for each defaulted day may be imposed.

18.36 Any lapses/ violations by the contractor of any of the terms and conditions, general and statutory requirements as specified in this bid will be penalized by GIPCL. Defaults like vacant Post/ indiscipline/ sleeping on duty/ intoxication etc. committed by the security & fire personnel will invite appropriate punitive measures as decided by competent authority of GIPCL.

18.37 GIPCL reserves the right to increase and/ or decrease and also to change the norms regarding deployment of Fire personnel due to exigencies of prevailing conditions with a written notice of 07 (seven) days, without giving any reasons. Payment to the contractor will be made as per actual duty performed and number of security & fire personnel deployed in a month and as per quoted rates.

18.38 At the time of deploying manpower, the Contractor shall strictly comply all the applicable labour laws/Acts norms including but not restricted to the age of the workers, women workers and shall also ensure that a police verification and security check for all the workmen/labour engaged at the GIPCL Site is done and necessary documents regarding the same shall be submitted to the GIPCL's authorized representative/officer-in-charge. Any default in complying with the same or any misrepresentation regarding compliance of the same shall compel GIPCL to initiate appropriate civil or criminal proceedings regarding the same.

18.39 The Contractor shall also comply with the safety requirements and provide his workmen/labour with safety equipment like helmets, masks, gum boots, a uniform (Minimum 03 pairs for AMC/ARC) and other necessary PPEs for properly undertaking the operations involved under this contract. Following are also to be issued by contractor:

• Hand gloves like electrical hand gloves / cotton hand gloves / Chemical hand gloves (As per requirement)

18.40 The contractor will issue good quality of uniform and other PPEs as mentioned above within 30 days of taking over the contract, failing which **penalty of Rs.250/-per day per default** will be imposed till issuance of all the PPEs to the entire fireman deployed in the plant.

18.41 Contractor shall nominate /authorize senior experienced person in writing as Site in- charge to co-ordinate with GIPCL Security & Fire Officer (in-charge) and who shall bear overall responsibility for performance of the contract. Such person shall remain always available at Site or Site office allotted to the contractor at Site. Contractor has to submit the authority letter and documentary proof for the same.

18.42 The Contractor shall appoint a supervisor who shall co-ordinate with GIPCL Security & Fire Officer (in-charge) for daily entrusted job. They have to maintain daily records dully signed for the works carried out and duly certified by Fire Officer (in-charge).

18.43 The Contractor in co-ordination with the GIPCL Security & Fire Officer (in-charge) shall ensure the availability of adequate manpower to carry out the job satisfactorily on a daily basis.

18.44 Contractor's supervisor will be responsible for complete supervision of the workforce engaged by him. He will be responsible for distribution of the duty posts as per requirement and arrangement for replacement of shortfall of personnel. He will also maintain all relevant records and report regularly as required under rules.

18.45 During emergency or similar situations, the Contractor shall be required to mobilize resources as per need within the period of 24 hours as directed by GIPCL. If the contractor fails to mobilize sufficient manpower to complete the job in time, GIPCL will execute the job through other agency at the risk and cost of the contractor with 10% supervision charges & the same will be recovered from the Contractor's bill.

18.46 Important Note: Whenever any of the Unit at Solar Park remains under outage due to any reason attributed to Security & Fire, the contractor shall mobilize sufficient work force at Site within a period of twenty-four hours from the time of intimation to the Site- in-charge or via mail to your office. Generation loss occurred due to want of manpower as well as resources will be viewed very seriously and will invite appropriate punitive measures as decided by competent authority of GIPCL.

18.47 During working in high risk area like the workman must wear a suitable safety apron, safety belt, safety hand gloves and goggles. It is the contractor's/contractor's supervisor's responsibility to ensure it without fail.

18.48 In case of fire or any other emergency or if Company receives call from OCR (Off Site Industrial Emergency Control Room) or any other Central Control and Monitoring Room, Contractor shall attend to the emergency and assist the fire crew or emergency service personnel as per the instruction of GIPCL's Authorized Officer.

18.49 All the miscellaneous activities pertaining to specific work to be executed for satisfactory performance is in the scope of Contractor in his quoted rates.

Accommodation, Food, Transportation & Miscellaneous.

18.50 The Contractor shall be responsible to make necessary arrangement for accommodation, messing, medical facility, seasonal comfort items as per the prevailing weather conditions, stationery, security equipment, uniform, accessories, sticks, torches, motorcycles for patrolling duties and any other equipment on the Site of deployment and discharge of duty needed by the security and fire safety personnel for effective discharge of their duties.

18.51 The Contractor shall be responsible for providing adequate and necessary means of transportation for transporting the security and fire safety manpower to and from their place of residence to the duty station. The contractor shall also deploy suitable vehicle/vehicles for carrying out night patrolling and ensuring the security of the assets of GIPCL in the park and ensuring that no perimeter breach takes place.

18.52 The Security & Fire Fighting personnel so provided shall be the Contractor's employees, wholly under his direct administrative control and supervision and the Contractor will be held solely responsible to take disciplinary action against them (or as directed by the GIPCL management) if they indulge any act of misconduct within the premises of GIPCL or outside during the tenure of the contract. However, decision taken by GIPCL official would be final and binding on the Contractor.

18.53 Security and Fire Fighting staff deployed at site by Contractor must be well trained and motivated, smartly dressed and have a disciplined conduct expected of an ex-soldier. GIPCL- SITE reserves the right to reject any personnel of the Security staff and decision of the controlling officer of GIPCL about deployment of manpower shall be binding on the Contractor.

18.54 The Contractor shall intimate regarding names, addresses etc. of Security and Fire Fighting staff personnel deployed by him from time to time to the GIPCL's Authorized Officer. The agency will also provide detail of each security and Fire Fighting personnel to the local police station immediately on taking over the contract and on monthly basis in case of new guards deployed in GIPCL. Service Discharge Book of ex-serviceman should be submitted, which should be available for Audit as and when required.

18.55 The Contractor shall issue Identity cards to all employees engaged by him with the instruction that the same should be produced by them on demand and shall at all times be carried by them while on duty.

18.56 The Contractor shall be responsible for overall administration and discipline of the security, vigilance and fire safety staff as well as for maintenance of equipment required for efficient performance of duties as per the scope of work. One administrator in charge should be posted at the Site location, who will be responsible for leave planning and relief of security staff, provision of dress, maintenance of equipment/ motorcycles, and arrangements for daily meals. He may also assist in disbursement of wages to security staff. The Contractor will not divert Security and Fire Fighting staff posted at site for such administrative use.

18.57 The Contractor will ensure that the Security and Fire Fighting staff deployed at the site are well behaved and observe discipline, good behaviour and conduct and maintain good housekeeping as required by GIPCL. The engaged personnel shall not be found drunken or under influence of drugs while they are on duty and during their stay in GIPCL premises. They should be physically and mentally sound with good eye sight.

18.58 The Contractor shall be responsible to make necessary arrangements for proper uniform with accessories, Lathi, shoes, raincoats, gumboot, jerseys, Beet books, registers, and all other equipment needed by the security staff for performance of their duties efficiently. The Security Officer and Security Supervisors must be provided one motor cycle each with fuel and maintenance cost by the Contractor for taking rounds and reaching their duty posts in their respective areas of responsibility. Following are to be issued by the Contractor to its manpower so deployed:

18.59 The Contractor's supervisor will be responsible for proper supervision of the workforce engaged by him. He will maintain all relevant records and report regularly as required under rules or/and directed by GIPCL officials and he will coordinate with them. He will also be responsible for distribution of the duty post as directed by GIPCL official and arrangement or replacement of shortfall of force.

18.60 Contractor should maintain one computer with printer for keeping daily records' maintaining the data and preparing reports.

18.61 The Company holds the Contractor fully responsible for the security and safety of premises, assets and peoples there in the plant, colony and the mines and other area of responsibilities. The Contractor will be held liable for any thefts or security lapse that may occur during the tenure of this contract. In case of any theft or loss of money, materials and assets of the company or of the employees due to lapse/negligence of Contractor's personnel, company will deduct the same value of the amount from Contractor's dues. In this matter the decision of GIPCL will be final and binding on the Contractor.

18.62 The Contractor will provide a daily / monthly confidential report on internal and external factors and other influencing factor including data on labour union activities, if any to the HOD Security.

18.63 As provided under Contract Labour Act, payment is to be made by 7th day of every month. The penalty up to Rs.500/- for each defaulted day may be imposed. Payment received from GIPCL should not in any way be linked to the payment of wages to the security personnel.

18.64 The contractor will make arrangement to issue Salary Slip to all his employees before or on the day of disbursement of payment.

18.65 Adequate reserve will be maintained for providing weekly off to security staff.

18.66 For the shortfall in prescribed number of guards, penalty of Rs. 500/- per day will be deducted from the Contractor's monthly bill. Decision of head of Security department in this regard will be final.

18.67 All Security Officers, Supervisors should have knowledge of basic computer operation as they have to perform their duties at the gate, Pass Section / Material Section which have computerized functions.

18.68 The Contractor is required to provide two lady guards (preferably ex- Paramilitary/police) for checking the female laborers as and when demanded by GIPCL.

18.69 Standard of the Security staff should be as under:-

(i) Security Officer- Age below 55 years; should be able to read and write English and Hindi.

(ii) Security Supervisor – Age below 55 years; should be able to read and write English and Hindi.

(iii) Security Guard – (Ex-Serviceman) age below 50 years; should be able to read and write English and Hindi.

(iv) The Ex-Serviceman Guards should be SHAPE-1,

(v) Civil Guards should be below the age of 45 years with minimum 175 Cms height, he should have well-built body, free from diseases communicable or otherwise.

18.70 The Contractor may be asked to provide Dog (Doberman or Alsatian breed) Squad with two handlers as and when required at his cost & expenses. Maintenance expenses for dog will not be paid.

18.71 GIPCL reserves the right to change the norms regarding deployment of Security Guards due to exigencies of prevailing conditions. Payment to the Contractor will be made as per duty performed by actual type and number of security personnel as per quoted rates.

18.72 Any lapses/ violations by the Contractor of any of the terms and conditions, general and statutory requirements as specified in this bid document will be penalized by the controlling officer of GIPCL-SITE. Defaults like vacant post/ indiscipline/ sleeping on duty/ intoxication etc. committed by the security staff will also be penalized as decided by the controlling officer of GIPCL. Repeated defaulters shall have to be removed from Site. A cumulative penalty, as directed by GIPCL official for all lapses, violations and defaults in a month, will be imposed and deducted from the bill of the Contractor for that month.

18.74 The Contractor shall make his own arrangements for the necessary arrangement for accommodation, messing, medical facility, seasonal comfort items as per the prevailing weather conditions, stationery, security equipment, uniform, accessories, sticks, torches, motorcycles for patrolling duties and any other equipment on the Site of deployment and discharge of duty needed by the security and fire safety personnel for effective discharge of their duties.

18.75 The contractor shall be responsible for providing adequate and necessary means of transportation for transporting the security and fire safety manpower to and from their place of residence to the duty station. The contractor shall also deploy suitable vehicle/vehicles for carrying out night patrolling and ensuring the security of the assets of GIPCL in the park and ensuring that no perimeter breach takes place.

19. <u>Clarification of Bidding Documents</u>

20. <u>TIME SCHEDULE</u>

The basic considerations and the essence of the 'Contract' shall be the strict adherence to the time schedule for performing the specified 'Works'.

21. UNDERSTANDING AND CLARIFICATION ON DOCUMENTS & SPECIFICATION

The Bidder is required to carefully examine the specifications and documents, all the conditions and matters work wise & cost wise. If any Bidder finds any discrepancies or omissions in the specifications and documents or is in doubt for any meaning of any part, he shall request in writing for an interpretation/ clarification to the GIPCL.

All such interpretations and clarifications shall form a part of the Bid documents.

22. <u>PAYMENTS</u>

All the payments against the work order shall be in Indian currency and payable through cheque/RTGS only.

23. POINTS TO BE CONSIDERED DURING QUOTING ONLINE PRICE BID

The schedule of rates shall be read in conjunction with Instructions to Bidders, General conditions of contract, Special conditions of contract and Technical specifications.

After commencement of the work, GIPCL, for any reason may not require to be carried out the whole/part of the work as specified in the tender, the security in charge shall inform the fact for thereof to the CONTRACTOR and contractor shall have no claim for any payment or compensation whatsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the full amount of the work not having been carried out nor shall he have any claim for compensation by reason of any change having been made in the original specifications and instructions which shall involve any curtailment of the work as originally contemplated.

SECTION-C

GENERAL CONDITIONS OF CONTRACT

1. CONTRACT SECURITY DEPOSIT/ PERFORMANCE BANK GUARANTEE

As a Contract Security/Performance Bank Guarantee, the successful Bidder, to whom the work is awarded, shall be required to furnish a **Performance Bank Guarantee (PBG)/Contract security deposit (SD)** in favour of Gujarat Industries Power Company Limited of an equivalent amount of **ten percent (10%) of the "Annual Contract Price excluding taxes and duties**" from any Schedule Public Sector Bank or Schedule Private Sector Bank, namely- All Nationalized Banks, Axis Bank, ICICI Bank, HDFC Bank, Kotak Mahindra Bank, IndusInd Bank, Federal Bank, Bandhan Bank, IDBI Bank, Karur Vysya Bank in the format attached in SECTION-F, and it shall guarantee the faithful performance of the 'Contract' in accordance with the terms and conditions specified in these documents and specifications. Contract security deposit/PBG shall be submitted strictly within twenty- one days from the date of LOI or Work Order, whichever is earlier. The PBG/ Security Deposit shall be valid up to retention period of four months from the contract completion date. The Guarantee amount shall be payable to the Company in Bidder's home currency without any condition whatsoever.

- (i) GIPCL reserves the right to forfeit Performance Bank Guarantee (PBG)/Contract Security Deposit.
- (ii) The Performance Bank Guarantee (initial Security Deposit) will be returned to the Vendor/Contractor without any interest at the end of the 'Retention Period' after completion of contract and on fulfilling contractual obligations throughout the retention period. However, any delay in submission of SD will result in equivalent late release of entire SD after guarantee period.
- (iii) Bid security/EMD should be refunded to the successful Bidder on receipt of Performance Security.

2. <u>RECOVERY CLAUSE</u>

- (i) In case of any damage of equipment/machinery due to negligence of Bidder or any other reasons attributed to Bidder the decision of the Controlling officer of GIPCL-in-charge regarding the amount of recovery shall be final and binding subject to a maximum of 10% of contract value. Recovery will be affected from the monthly bills and/or retention money/security deposit.
- (ii) If the Bidder fails to execute the work as per directions of the Controlling officer of GIPCL within the time frame given in work order and as per day to day instructions by the Controlling officer of GIPCL-in-charge, GIPCL shall get the work done by third party at the risk & cost of the Bidder with 10% additional overhead charges of GIPCL.

3. DEDUCTIONS FROM CONTRACT PRICE

All costs, charges or expenses that GIPCL may have paid, for which, under the contract the Bidder is liable, shall be recovered by the GIPCL. The Bidder shall pay all such claims within 15 days of claim failing which the same shall be deducted from the bills of Bidder.

4. TERMINATION OF CONTRACT BY GIPCL

Contractor shall be responsible to complete the jobs within agreed time schedule and in case contractor fail to complete the job, GIPCL shall recover from his bill, Security Deposit and / or whatsoever for expenses incurred to complete the job with additional 10% overhead charges.

In case if contractor's services are not found satisfactory with respect to mobilization, time bound completion of work, workmanship & safety (OHSAS policy of GIPCL) etc then GIPCL has right to terminate the contract at any time by giving him 15 days advance notice without assigning any reason and will make the alternate arrangement at the risk & cost of contractor.

GIPCL may terminate the contract after due recoveries of pending jobs/damages after giving 15 days advance notice to the contractor if any of the following events occur –

- (i) Contractor is adjudged as insolvent.
- (ii) Contractor has abandoned the contract.
- (iii) Contractor fails to proceed with the work with due diligence as per requirements of the contract.
- (iv) Contractor has neglected or failed persistently to observe or perform any of the acts, matters or things, which as per the contract are to be observed and performed by the contractor.
- (v) Contractor repetitively violating the safety norms for more than three incidents.
- (vi) Any major contradiction of applicable labour laws.
- (vii) Any major deviations from contractual terms and conditions including quality of job.
- (viii) GIPCL reserves the right to terminate the contract without giving any reason whatsoever and forfeit the PBG

5. FAILURE & TERMINATION

If the CONTRACTOR after receipt of written notice from the GIPCL/ Security In-charge requiring compliance, with such further drawings and / or the GIPCL /Security In-charge **instructions fails within seven days to comply** with the same, the GIPCL / Security In-charge may employ and pay other agencies to execute any such work whatsoever as may be necessary to give effect thereto and all costs incurred in connection therewith shall be recoverable from the CONTRACTOR

by the GIPCL on a certificate by the GIPCL/ Security In-charge as a debt or may be deducted by him from any money due or to become due to the CONTRACTOR.

If the contractor fails to execute the work or fails to mobilize the resources and equipment as per directions of GIPCL / Security In-charge within the time frame given and/or violating the GIPCL's safety rules & regulations, Security In-charge/ GIPCL shall get the work done by third party at the risk & cost of the CONTRACTOR with additional 10% overhead charges of GIPCL and all costs incurred in connection therewith shall be recoverable from the CONTRACTOR by the GIPCL / security incharge as a debt or may be deducted by him from any money due or to become due to the CONTRACTOR.

6. <u>SETTLEMENT OF DISPUTES</u>

- (a) Any disputes or difference of opinion between parties arising out of the contract to the extent possible shall be settled amicably between the parties. If amicable settlement cannot be reached all the disputed issues shall be resolved through arbitration before a Sole Arbitrator appointed by Managing Director, GIPCL according to the provisions of The Arbitration & Conciliation Act-1996, as amended from time to time. The place of arbitration shall be at Vadodara.
- (b) Work under the contract shall be continued by the Bidder during arbitration proceedings unless GIPCL shall order suspension thereof or any part thereof in writing or unless the matter in such work cannot possibly be continued unless the decision of the Arbitration proceedings is obtained.

7. INTERPRETATION OF CLAUSE

In case of disputes as regards interpretation of any of the clauses or specification, the decision of Head of Management (HOM)-GIPCL will be final and binding on the Bidder.

8. EMPLOYEE'S COMPENSATION INSURANCE

Contractor shall take all risk Insurance Policy to cover all his workmen/employees, staff applicable under the Employee Compensation Act 1923 or any amendment thereof as also insurance cover for third party liability. The Contractor shall keep the GIPCL indemnified from all liabilities arising out of his action in pursuance of this contract. The E. C. Policy should be obtained from Baroda/Surat Jurisdiction (As per Work Location) and shall be assigned to GIPCL. EC policy should cover the specified contract period.

Contractor shall also obtain additional off-duty coverage insurance policy for all his manpower.

9. STATUTORY REQUIREMENTS

A. COMPLIANCE OF LABOUR LAWS

The Contractor shall at his own cost comply with the provision of labor laws, rules, orders and notifications whether central or state or local as applicable to him or to this contract from time to time. These Acts/Rules include without limitation of the followings.

- Contractor shall be solely responsible and shall fully comply with all the provisions of all the labor laws applicable such as the Minimum Wages Act, 1948, Contract Labor (Regulation & Abolition) Act 1970, Factories Act, 1948, Payment of Bonus Act 1965, Employees Provident Fund and Miscellaneous Provision Act 1952, Industrial Dispute Act 1947, Workmen Compensation Act 1923, Payment of Gratuity 1972, Interstate Migrant Workmen Act 1979, Equal Remuneration Act with Rules, Order and Notifications issued/made there under from time to time.
- 2. All other Acts, Rules/Bye-Laws, Orders, Notifications etc. present or future applicable to the Bidder from time to time for performing the contract job.
 - 2.1. The Contractor shall provide and be responsible for payment of Wages, Salaries, Bonus, Social charges, Insurance, Food, Accommodation, Transport, Medical and Canteen facilities and other statutory privileges and facilities to his personnel as per law/rules/regulations and orders of the Central Government, State Government, Local Authorities or other authorities as are in force from time to time. All employees of the Bidder shall be employee of the Bidder.
 - 2.2. The Contractor shall have a valid license obtained from Licensing Authority under the Contract Labor (Regulation & Abolition) Act-1970 at the time of execution of the contract covering all his employees working at SITE Site and furnish the same failing which GIPCL may terminate the contract at its sole discretion.
 - 2.3. The Contractor shall at the time of execution of the contract have a EPF Code Number obtained from the Authorities concerned under the Employees Provident & Miscellaneous Provisions Act, 1972 and remit contributions in respect of the employees employed by him at SITE Site to the P.F office concerned every month failing which GIPCL will recover from the outstanding payment to the Bidder from GIPCL.PF code of Gujarat region should be taken.
 - 2.4. The Contractor shall maintain all records/registers required to be maintained by him under various labor laws mentioned above and produce the same before the Statutory Authorities whenever required.
 - 2.5. The Contractor shall also submit periodical reports / returns to the various statutory authorities such as the Contract Labour (Regulation & Abolition) Act1970, Employees Provident Fund Act etc. Under intimation to HR&A Department.

- 2.6. The Contractor shall not pay less than the Minimum Wages notified by the Government from time to time to his employees of corresponding categories.
- 2.7. The Contractor shall be responsible for payment of overtime wages to his workmen, if any, in case they are required to work beyond the prescribed hours under law as per applicable rates.
- 2.8. The Contractor shall take Workmen Compensation Insurance Policy for all his employees working at GIPCL. The Contractor shall indemnify the company against any liability due to any work injury or accident to any of its employees.
- 2.9. The Contractor shall in the event any of his workmen / employee sustains any injury or disablement due to an accident arising out of and in the course of his employment, provide necessary medical treatment and pay compensation as applicable, required under the Workmen's Compensation Act, 1923.
- 2.10. If any of the persons engaged by the Contractor misbehave with any of the officials or the Company or commit any misconduct with regard to the property of the Company or suffer from any serious communicable disease, the Contractor shall replace them immediately.
- 2.11. The Contractor shall not engage / employ persons below the age of 18 years. Employment of women shall be strictly according to applicable laws.
- 2.12. GIPCL will have right to deduct and disburse the claims of the individual / parties being a principal employer on any account whatsoever in relation to their employment with the Contractor. The Security deposit will be released to the Contractor at the end of the contractual tenure subject to an undertaking by the Contractor that in the event any of his workmen or the heirs of workmen puts up a claim for recovery of money due to him from the Contractor before the appropriate authority under the I.D. Act, 1947 or under any other labor laws or for compensation under the Workmen's Compensation Act, 1923 and the appropriate authority has given a direction for making payment the Bidder will meet the same or indemnify GIPCL if in the event GIPCL pays it as Principal Employer.
- 2.13. The Contractor shall make payment of wages to his employees on fixed date within the period specified under the applicable Law, in presence of representative of the company. He will submit a true copy of wage sheet, attendance register and P.F. remitted challans on monthly basis to HR&A dept. for verification and record.
- 2.14. The Contractor shall provide Safety items / kits to his employees such as safety shoes, goggles, ear plugs, hand gloves, safety belts etc., if any, required under the law.
- 2.15. The Contractor shall conduct pre-induction and periodic medical checkup of his workmen/guards as per applicable laws.
- 2.16. The Contractor shall be solely responsible for any accident caused to his guards and should adhere to all rules / regulations as per labor laws of Government and other statutory laws as applicable.
- 2.17. The Contractor should register himself under the Contract Labor Act, Employee Compensation Act and PF Act (Code no. to be mentioned) and submit the copy of registration certificate and

should possess the same from the date of commencement of work, failing which the contract is liable to be cancelled. The E.C. Policy copy should be submitted to the GIPCL before commencement of the work and Labor License should be obtained within one week from the date of issue of form-V. Contractor should apply for Form-V immediately after receipt of LOI. A copy of Labour License shall be submitted to GIPCL, HR & A Department.

- 2.18. Contractor shall have to insure his guards /supervisors etc. under Group Insurance scheme.
- 2.19. The Contractor shall be responsible for compliance of all statutory rules, regulation, act enforced from time framed by the government such as Factory

Act, Employee Compensation Act, Payment of 'Wages Act', Minimum Wages Act', Provident Fund Act, All Labor Laws/Acts in respect of employees engaged by him for the work and shall have to maintain necessary records. In case any amount becomes due to be payable by him to his employees or to the Government under the above rules, regulation, Acts, GIPCL reserves the right to recover the same from the running bill of the contract.

- 2.20. Documentary evidence of deposit of PF paid shall have to be produced by the Contractor along with the next bill.
- 2.21. Records as per the provisions of various statutory Acts will have to be maintained by the Contractor and submitted as and when required.
- 2.22. All employees of Contractor should maintain due discipline and respect local sentiments. GIPCL reserves the right to direct the Contractor to remove any such person who does not comply with it.
- 2.23. The list is indicative in nature and not an exhaustive one. Any amendment/alteration/Notifications or addition to the existing Law or a new statute shall automatically and immediately become applicable.
- 2.24. **Annual Health Check Up:-** As per statutory requirement, Contractor has to inform his staff deployed at Site for annual health check-up as per schedule prepared by HR&A department.

B. LEGAL ASPECTS

- (i) Contractor shall maintain all register required under the Labour Laws and make the payment as per the Minimum Wages Act to the manpower employed by him.
- (ii) Contractor shall obtain requiSite license to carry out this contract under the provisions of Contract Labour Act, 1970 and maintain necessary records and registers under the said Act.
- (iii) Contractor shall submit a copy of each of the registration certificates with respect to Employees Provident Fund and Employee Compensation Act within one week's time, from the date of award of this contract.
- (iv) Contractor's employees, agent or sub-agent shall not smoke or light anything within the premises of the GIPCL and carry match box / lighter or any other explosive and /or inflammable material inside the plant.

- (v) Contractor shall abide by all the statutory rules and regulations like P.F, Labour Laws etc.
- (vi) Contractor shall issue an appointment order to each of his manpower stating therein the nature of job to be performed by him and fix time for which the concerned guards, etc. are likely to be deployed. Bidder shall also issue a temporary identity card specifying the period for which the guards, etc. has been deployed.
- (vii) Contractor is fully liable for the persons engaged by him for above work; however, GIPCL reserves the right to deduct any amount legally justified towards any liability not fulfilled.
- (viii) Contractor shall indemnify GIPCL from any liabilities arising out of the employment of the manpower.
- (ix) If the Contractor fails to complete the allocated job within specified time frame, GIPCL shall get the work done by third party at the risk and cost of Contractor.

10. PAYMENT OF WAGES

Contractor shall make payment to his workmen through on-line mode only. Contractor shall be responsible for compliance of all statutory rules, regulation, act enforced from time framed by the government such as Factory Act, Employee Compensation Act, payment of 'Wages Act', Minimum Wages Act', Provident Fund Act, Payment of Bonus Act, Labor Law Act, maternity benefit act in respect of employees engaged by him for the work and shall have to maintain necessary records. In case any amount becomes due to be payable by him to his employees or to the Government under the above rules, regulation, Acts, GIPCL reserves the right to recover the same from the running/final bill or Security Deposit of the contractor.

11. ACCIDENT TO WORKMEN

Contractor shall be fully responsible for injury or death of any of his workmen due to any act omission / indiscretion on his part while undertaking the work and Contractor shall fully abide by the statutory requirements of the employee's compensation act. GIPCL shall not be liable for any compensation due to accident, death or injury to any of Bidder's workmen or any third party due to negligence, act or omission on contractor's part.

12. LIGHTING

Necessary illumination at works area will be provided by GIPCL. However, the contractor shall provide Hand Held Search Lights, quantity 01 between two guards deployed in Night Shift

13. NIGHT/SUNDAY/HOLIDAY SHIFT

The Contractor shall depute qualified and adequate resources on night shift/Sunday/holidays for any emergency job, which may come up at night/Sunday/holiday.

14. SAFETY ASPECT

Contractor shall observe all the safety and security rules and regulation of the GIPCL which are at present in force and which may come into force during the pendency of the contract. Any violation of any rules and regulations will entail immediate termination of the contract.

The contractor has to submit the list of required safety gears along with safety equipment available with him to the Safety Deptt. Safety Deptt will check for quantity and quality of the safety gears and then give permission of work. Poor quality material will not be allowed inside the Plant. If quantity of required safety equipment is not satisfactory, contractor will not be allowed to carry out the work using such safety gears inside the Plant.

15. GENERAL SAFETY CLAUSES:

- a. The Contractor shall observe and comply, with regard to his workmen working at the SITE Site, the safety norms as per the safety operating standards.
- b. The Contractor shall ensure that his workmen are informed and trained regarding the safety standards to be adopted while operating within the SITE Plant & Mines premises and the Contractor shall brief them regarding the same and use of the Personal Protective Equipment ('PPE').
- c. The Contractor shall issue safety shoes and safety helmet of IS standard to all his workmen immediately on execution of the work and the Contractor shall ensure that his workmen wears the protective equipments at all times during the work operation. Contractor shall issue safety shoes every year. Brand name for safety shoe & safety helmet shall be suggested by safety representative of GIPCL. Such as:-

- d. Other safety gears like ear plug, dust mask, hand gloves, safety goggles, gum boots, full body safety uniform and belts, safety net etc. shall be issued and used as per the job requirements. Safety helmet shall be of YELLOW COLOUR ONLY. Contractor will procure safety shoes & safety helmet from a reputed company with at least 12 months' guarantee and shall produce the guarantee certificate and IS standard certificate to the Safety Department. Contractor should purchase safety shoes of reputed brands. Safety shoes will be issued every year. IS certificate and guarantee certificate must be obtained from the vendor and submitted to the Safety Department. Safety shoes should be heat, water, oil and chemical resistant, having an anti-slippery sole of 15298- 2002 make.
- e. It is the duty of Contractor to ensure that his workmen are wearing required PPEs as per work requirement. Contractor should ensure that their workers are wearing Safety helmet, safety shoes, dust mask, goggles, ear plug etc. at all times when they are at work throughout the contract period. The Contractor has to maintain the PPE Issue Register with signature of workmen.
- f. Contractor will reissue these PPEs in case of damage or misplacement of the same. Replacement shall be made immediately.
- g. The Contractor shall be responsible for providing first aid or emergency medical help and treatment to his workmen in the event of any accident or injury.
- h. If it is observed that Contractor is not issuing required PPEs timely and that of required quality, GIPCL will issue the required PPEs to contract workers and back charge the same with 25% overhead charges of GIPCL.
- i. All vehicles shall be operated by licensed drivers only. All vehicles' PUC to be tested as per Government approved RTO guidelines. All Vehicles must be parked in Parking space designated by GIPCL. If any vehicle is found inside the plant premises other than the parking area such vehicles shall be handed over to Security Department and their entry shall be cancelled for movement inside the plant premises with immediate effect.
- j. The Contractor shall fill up Incident notification form (S-I), Incident Investigation form (S-II) and near miss report within time limit as specified in forms, if any accident, Incident, near miss occurred while working at SITE.
- k. Major AMC / ARC Contractor (Where the manpower strength is more than 50 and above) should appoint / nominate one qualified safety officer and he shall be responsible for addressing all the safety related aspects of execution of contract jobs and he will be in close co-ordination with safety officer of SITE and attend all safety related meeting such as safety committee, on job safety training etc. Where the contractual man power is less than 50, the Site in-charge of the Contractor will act as a safety officer and he will perform all the duties of safety officer as mentioned above.
- 1. All the vehicles shall be fit as per RTO guidelines and valid fitness certificate is required as per RTO guidelines.
- m. The Contractor's nominated safety officer shall be imparted regular on-job safety training like tool-box talk etc. and submit a record of such training in safety dept, respective dept and

HR&A Department

- n. The Contractor shall comply with all the new requirements related with safety as informed by the HOD / Safety department from time to time.
- o. Penalty to be imposed for Violation of safety norms is proposed as follows:-

The Contractor & Contract workmen shall strictly adhere to Safety standards / Guidelines as per practices. The list provided below is an indicative list to explain the principles behind safety practice. If the contract workmen fail to comply with safety standards as per category A, B & C below, penalty shall be levied on the Contractor as per the table mentioned below:

Penalty so levied against the Contractors and company employees will be used during the observation of National Safety Day.

The Contractor, workmen following good safety practices in their work area continuously will be rewarded / honoured on National safety day.

16. **REJECTION OF WORK**. If, as a result of inspection, examination or testing, the GIPCL's Representative/Engineer decides that any materials, work or workmanship is defective or otherwise not in accordance with the Contract, the GIPCL/ GIPCL's Representative may reject such plant, materials, work or workmanship and shall notify the CONTRACTOR promptly, stating his reasons. The CONTRACTOR shall then promptly make good the defect and ensure that the rejected item complies with the Contract. If Contractor failed to rectify the rejected work or workmanship. GIPCL reserves the right to deduct or withhold amount against rejected work or Workmanship. CONTRACTOR shall not entitle for any claim or release of hold payment until rectify the defect up to satisfactory of GIPCL. If Contractor failed to rectify any such defective work or workmanship, GIPCL reserve the right to rectify at risk and cost of the CONTRACTOR and deducted by the GIPCL from any amount due, or to become due, to the CONTRACTOR's dues.

If the GIPCL/Engineer/GIPCL's Representative requires such materials, work or workmanship to be retested, the tests shall be repeated under the same terms and conditions. If such rejection and retesting cause the GIPCL additional costs for the traveling and lodging costs of GIPCL's personal for attending the retest, such costs shall be recoverable from the CONTRACTOR by the GIPCL and may be deducted by the GIPCL from any amount due, or to become due, to the CONTRACTOR.

17. GENERAL TERMS AND CONDITIONS:

- a) All tools & tackles, manpower, equipment, vehicles, etc. to execute the contract are in the scope of the Contractor. The Contractor should ensure that tools equipment are in healthy condition.
- b) The decision of the controlling officer of GIPCL shall be final and binding on the Contractor for defining the terms and condition included in this contract.
- c) If the work is not found satisfactory, the controlling officer of GIPCL reserves the right to take suitable action.
- d) Contractor shall depute Location wise full time independent experienced Sitein charge and two nos. of independent Site supervisors at Site. They shall coordinate with GIPCL officer in-charge and shall bear overall responsibility of contract including duty deployment, billing etc. Such person shall function from Site office of Contractor at SITE.
- e) Contractor shall also nominate one safety supervisor at Site and shall submit nomination of safety supervisor in writing before commencement of contract. Safety supervisor shall arrange small safety talk on every day morning or whenever required with all manpower working under this contract. He shall coordinate with security department's officer-incharge on daily basis and report daily observations, tool-box talk records etc.
- f) The contractor has to submit daily reports showing work carried out with details of available manpower, tractors etc.
- g) Any job other than the listed jobs in work order shall be executed by the contractor on instruction from GIPCL and payment shall be made to the contractor on respective item rate only.
- h) The contractor has to take EC insurance policy for his workmen. The contractor has to submit labor license and PF account number to the officer in-charge before starting the work.
- i) Contractor shall mobilize the resources as per need within the period of twentyfour hours. If the contractor fails to mobilize sufficient resources to complete

the job in time, GIPCL will execute the job through other agency at the risk and cost of the contractor with additional 10% overhead charges.

- Contractor should mobilize all resources for efficient & smooth execution of contract within seven to fifteen days from the date of issue of Letter of Intent/Work Order.
- k) Contractor must fulfill all the safety regulations and to take safety measures to avoid hazards. Contractor shall arrange all standard adequate healthy safety PPEs like but not limited to approved quality safety shoes& safety helmets, standard dust masks, safety goggles, etc... as required and shall use exclusively under this contract for all the time during working at specified locations failing which, security in-charge may hold the work and will take necessary action including penalty as decided. If the contractor repeatedly violates safety rules/regulations (more than three successive incidents), security in-charge may take necessary action against the contractor, including appropriate financial penalty and/or termination of contract.
- 1) One or more jobs may be required to be done simultaneously and contractor shall mobilize additional resources accordingly.
- m) Timely completion of all jobs and works shall be the essence of this Contract. Contractor should closely monitor each activity and complete the jobs as per the time given by and under the supervision of the officer-In-charge and shall ensure that sufficient manpower is deployed for the same.
- n) The contractor has to submit daily reports showing work carried out with details of available manpower, etc.
- o) The Government of India has enacted the Micro, Small and Medium Enterprises Development Act, 2006 (the "Act") and the Act has come into force from October 2, 2006. The Contractor shall confirm whether his organization is registered under the Micro, Small and Medium Enterprises Development Act, 2006. If your organization is registered under the Act, please specify the category i.e., Micro Enterprise, Small Enterprise or Medium Enterprise under which it is registered and kindly attach a copy of your registration certificate.
- p) The Contractor shall provide details of registration along with copy of the registration certificate issued by the District Industries Centre/Department of Industries, etc of the respective State Government. It is to be noted that large scale industries and trading firms have been excluded from the purview of the Act.
- q) GIPCL is an ISO 9001, ISO 14001, OHSAS 18001 & ISO 50001:2011 (EnMS) certified company, and GIPCL gives extreme importance to maintain these global standards.
 Contractor shall be required to observe these standards while working with GIPCL. Contractor shall be required to asserve these standards while working with a second standard.

GIPCL. Contractor should ensure that his workmen/guards work in accordance with them.

- r) The contractor shall submit his monthly RA bill within three days of the completion of a calendar month. It must be supported by authentic/original documents, which clearly indicate complete compliance of all statutory provisions/ acts.
- s) The contractor must pay entitled wages of all the security personnel within seven days of completion of the calendar month. Any delay in payment of wages shall constitute a statutory violation for which appropriate legal action may be taken by GIPCL-SITE as per Contract Labor (Regulation & Abolition) Act, 1970. Payment received from GIPCL should not in any way be linked to the payment of wages to the security personnel.

- t) Wages of security personnel to be paid by the contractor after statutory deductions, if any, and payment of wages should be as per payment of wages Act and Factory Act.
- u) Earnest Money Deposit (Non-interest bearing) along with the pre-qualification bid will be converted as Security Deposit (non-interest bearing) in case of successful Bidder and will be returned only after satisfactory completion of the BRC.
- v) EMD amount of unsuccessful bidders will be refunded once LOI/WO is issued to successful bidder for new BRC.
- w) The biennial rate contract shall be valid for a period of Two years and on completion of the same it will stand terminated unless it is extended/ renewed as per mutual agreement.
- x) GIPCL-SITE can terminate the BRC at any time by giving 15 days' notice in case performance of the Contractor is found to be unsatisfactory or for any other reasons deemed fit for termination. On the other hand, the Contractor would be required to extend the contract for a period of 3 months at the same rates, terms & conditions on completion of the contract period, if so desired by GIPCL.
- y) GIPCL shall also conduct an orientation program appraising the workmen regarding the safety norms and measures to be observed during work operations at the plant Site.

17. PUBLIC HOLIDAYS

The Bidder shall be responsible for giving benefit to all his employees, employed in whatsoever capacity, 09 Public/Paid holidays and the same shall be notified in advance and due communication thereof shall be made to the Management.

18. <u>BENEFIT PAYABLE IN CASE OF ACCIDENT OCCURRING OUTSIDE PREMISES OR</u> <u>BEYOND THE COURSE OF EMPLOYMENT</u>

The Contractor shall provide an insurance coverage (Medical + Death Benefit) for sum of Rs. 01/-Lakh to all his workmen/guards deployed at GIPCL site for the accident taking place anywhere outside the Company premises or at any place when the workman is not in course of his employment.

19. FORCE MAJEURE

The performance of the obligations herein contemplated may be suspended without incurring the penalty in the event of the subsistence of Force Majeure conditions.

If a Force Majeure situation arises, the affected Party shall promptly notify the other Party in writing of such conditions and the performance shall be suspended as per mutual agreement.

For the purposes of this clause, 'Force Majeure' means an event beyond the control of the Party and not foreseeable by the Party and shall include events of floods, explosions, riots, wars, hurricane, epidemics, any other Act of God, quarantine restrictions, terrorism, government actions and provided always that such acts result in the impossibility of the further performance of the contract

20. INDEMNITY

The Contractor shall indemnify and keep harmless GIPCL from and against all actions, proceedings, claims, demands, losses, costs, damages and expenses whatsoever which may be brought against or suffered by GIPCL which it may sustain, pay or incur as a result of or in connection with the performance/ purported performance/ non-performance of the contract by the Contractor.

In case, in any litigation pertaining to manpower employed through contractor if any direction or order is issued by court at any point of time the contractor shall comply with and implement such direction or order whether passed at the time of award of contract or during the pendency of contract. Further, the Contractor shall indemnify the GIPCL against all consequences arising and affecting GIPCL owing to the compliance of the orders by the Contractor.

21. GOVERNING LAW AND JURISDICTION

This tender document and contract shall be governed by the laws of India and the Courts at Baroda/Surat shall have jurisdiction regarding the same.

23. Where any portion of the General Condition of Contract is repugnant to or at variance with any provisions of the Special Condition of Contract, then unless a different intention appears, the provision of the Special Conditions of Contract shall prevail to the extent of such repugnancy of variance.

SECTION-D

SPECIAL CONDITIONS OF CONTRACT

1. DETAIL SCOPE OF WORK

Security Services.

1.1 The Contractor shall deploy not less than 50% ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel) having sound physical and mental health. Security Officer cum Fire Officer should be JCO/Equivalent rank below 55 years of age, Security Supervisors should be JCO/NCO/Equivalent below 55 years of age and Security Guards below 50 years of age. Ex-servicemen's/ paramilitary personnel's original documents must be submitted to the GIPCL official at the time of initial deployment of each and every security personnel at GIPCL for verification and copy thereof made available for records subsequently.

1.2 It is expected that the contractor deploys 100% ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel) however in exceptional case the remaining strength, i.e. not more than 50% only in Security Guards will be of Smart/good looking, experienced civilian guards with the height not less than 175 Cms. Minimum experience in security duties in Industries should not be less than 5 years. Background check of the civilian guards should be conducted by the Contractor and they should be deployed after proper police verification. It should be clearly understood by the contractor that the civilian guards, if employed will not be kept at par with ex-servicemen security staff (i.e. Ex-Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police/auxiliary force personnel / Ex-Nepal & Bhutan Army Personnel/ Home Guard Personnel), the civilian guards, if employed by the contractor will be categorised as unskilled for payment of wages.

1.3 Out of the total strength of guards being deployed minimum 6 Guards should be qualified drivers and should possess a valid light vehicles driving license. They should be able to drive the Quick Response vehicles and any other company provided or contractor provided vehicles as and when required by the company's designated officials.

1.4 The security personnel deployed by the Contractor should be competent and proficient in handling and operating state of the art CCTV cameras and surveillance equipment. Certificate in this regard will be submitted by the Contractor.

1.5 The Contractor shall protect the GIPCL's property and persons round the clock, and if required, during their commute from residence to the company and vice versa.

1.6 The Contractor shall disallow trespassing of unauthorized persons in the Plant or any other premises belonging to GIPCL.

1.7 The Contractor shall deploy adequate number of persons for effective and efficient services which should include Security officers, Supervisor, Guards, etc., Number of security guards shall be increased or decreased & shall be provided in accordance with the requirement of GIPCL from time to time.

1.8 The Contractor shall depute trained security officers, security supervisors and security guards who are competent in security matters and shall take all measures to prevent any security breaches.

1.9 The Contractor shall be responsible to monitor vehicular traffic at GIPCL gates and inside GIPCL's premises and carry out proper search of GIPCL's employees, laborers, visitors, materials etc., to ensure safety & security of its personnel & property and to prevent illegal exit of GIPCL's property.

1.10 Contractor shall also guide the visitors after completing requisite procedure and perform such other related functions of the security as assigned by the designated official of GIPCL.

1.11 The Contractor shall check and verify incoming and outgoing vehicle, equipment and material and monitor loading and unloading of materials in the GIPCL's premises.

1.12 The Security personnel posted must be free from communicable cardiovascular diseases, infections & surgeries. Candidate should not have a past history of mental illness. The nose, ear & throat should be in perfectly fit condition.

1.13 The Physical Fitness Test (PFT) – to determine the physical fitness of a guard following tests shall be conducted – (a) 0.5 Km running (within 3 minutes); (b) Balance Routine; and (c) Parade/Drill. Report of the Physical Fitness Test is to be submitted with physical standards of each candidate as mentioned in the condition of deployment of manpower.

1.14 GIPCL reserves the right to reject any security personnel if not found suitable.

1.15 In case of any abnormal situation sensed/seen by the Contractor's personnel related to security, vigilance and fire at premises of the GIPCL either from an insider or from outside persons (including nearby villages), a regular written report by the Contractor shall be submitted to the GIPCL's Authorized Officer.

1.16 The Contractor shall agree to take additional job assignments and shall deploy sufficient additional security force as & when required by GIPCL during the tenure of the contract. Additional charges shall be payable at mutually agreed rates.

1.17 In case of any theft and loss of property of GIPCL on account of negligence of guards, the same will be reimbursed by the Contractor or alternatively will be adjusted against payments due to the Contractor.

1.18 The Contractor shall be responsible for control and overall supervision of security personnel deployed by him and shall observe all rules and regulations of the GIPCL. The security personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

1.19 The Contractor shall be responsible for the completion of the job as defined in this tender and in case he fails to do so; the GIPCL shall recover from the Contractor cost whatsoever incurred for the same.

1.20 The day to day instruction for the work and any clarification regarding specifications for the various items shall be given by the GIPCL's Authorized Officer & his instructions & clarifications/interpretations shall be final & binding to the Contractor.

1.21 The Contractor shall have to engage well-trained and experienced Ex-service man/guards in shifts and after office hours as well as during holidays according to the exigencies of the work. No claim or representation on this account shall be entertained by GIPCL.

1.22 The Contractor shall take full liability of the persons engaged by him. GIPCL reserves the right to deduct any amount legally justified towards any liability not fulfilled by the Contractor. I

1.23 It is the responsibility of the Security Agency to protect the Solar park, to ensure that no trespass takes place into company premises and also to ensure that no material is moved out by anyone by any means without authorization, and in case of an incident, same shall be brought to the immediate attention of GIPCL management in writing.

1.24 The Contractor's responsible Officer should take round of the GIPCL's premises during the night hours, at least once in the fortnight and submit the report in writing to the GIPCL's Authorized Officer in morning of the next day.

Fire Safety Role

1.25 The Contractor shall deploy suitably qualified and sufficient manpower for timely & satisfactorily execution of the works under the contract. Qualification of the fire safety staff is prescribed below:

a)	Fire Supervisor	12 th pass,06 months' fireman course with minimum 3 years of experience, below the age of 55 years
c)	Fire Driver cum Operator	12 th pass,06 months' Fireman Course, Valid Heavy Vehicle License, minimum 2 years of experience, below the age of 50 years.
d)	Fireman	12 th pass,06 months' fireman course with minimum 1 year of experience, below the age of 45 years.

1.26 The Contractor shall be responsible for all fire safety control and overall supervision of fire safety personnel deployed by him and shall observe all rules and regulations of the GIPCL. The fire safety personnel deployed shall be smart, in proper uniform, properly groomed, should maintain discipline and decorum.

1.27 The Contractor shall deploy the necessary Fire Fighting Equipment at critical Sites as required by the Fire Safety Officer of GIPCL. The Contractor shall also conduct the weekly inspections and replenish any Fire Fighting Equipment found to be faulty, non-functional or empty. The Contractor shall comply with the industrial Fire Fighting Standard Operating Procedures and any failure to comply to the would invite necessary penalties as deemed fit the management of GIPCL.

1.28 Contractor shall be responsible for providing Fire services at GIPCL as per requirement. In the event of any shortfall in the number of fire personnel for any reasons whatsoever it will be contractor's responsibility to replenish the requisite number of fire personnel and ensure that at no time post will be left unattended.

1.29 It must be clearly understood by the contractor that the total strength of the fire personnel may be differing depending upon various factors. Contractor will reduce or increase strength as required after consulting head of Fire/Fire department, GIPCL.

1.30 Fire personnel deployed at Site by contractor must be well trained and motivated, smartly dressed and have a disciplined conduct expected of Firemen. The fire personnel shall not be found drunken or under influence of drugs while they are on duty. They should be physically and mentally sound with good eye sight.

1.31 The contractor shall be responsible for overall administration and discipline of the security and fire personnel deployed by him as well as for maintenance of equipment required for efficient performance of duties as per the scope of work and maintain good housekeeping as required by company.

1.32 The security and fire personnel so provided shall be contractor's employees, wholly under contractor's direct administrative control and supervision and contractor will be held solely responsible to take disciplinary action against them if they indulge in any act of misconduct within the premises of the GIPCL or outside during the tenure of the contract.

1.33 Adequate reserve for security and fire personnel will be maintained for providing weekly off to security and fire personnel.

1.34 Any shortfall in strength may attract Rs.500/- per day. Decision of head of Security/Fire department will be final in this matter.

1.35 Contractor will ensure that payment is made to his security & fire staff by 7th of every month. The penalty up to Rs.500/- per day for each defaulted day may be imposed.

1.36 Any lapses/ violations by the contractor of any of the terms and conditions, general and statutory requirements as specified in this bid will be penalized by GIPCL. Defaults like vacant Post/ indiscipline/ sleeping on duty/ intoxication etc. committed by the security & fire personnel will invite appropriate punitive measures as decided by competent authority of GIPCL.

1.37 GIPCL reserves the right to increase and/ or decrease and also to change the norms regarding deployment of Fire personnel due to exigencies of prevailing conditions with a written notice of 07 (seven) days, without giving any reasons. Payment to the contractor will be made as per actual duty performed and number of security & fire personnel deployed in a month and as per quoted rates.

1.38 At the time of deploying manpower, the Contractor shall strictly comply all the applicable labour laws/Acts norms including but not restricted to the age of the workers, women workers and shall also ensure that a police verification and security check for all the workmen/labour engaged at the GIPCL Site is done and necessary documents regarding the same shall be submitted to the GIPCL's authorized representative/officer-in-charge. Any default in complying with the same or any misrepresentation regarding compliance of the same shall compel GIPCL to initiate appropriate civil or criminal proceedings regarding the same.

1.39 The Contractor shall also comply with the safety requirements and provide his workmen/labour with safety equipment like helmets, masks, gum boots, a uniform (Minimum 03 pairs for AMC/ARC) and other necessary PPEs for properly undertaking the operations involved under this contract. Following are also to be issued by contractor:

1.40 The contractor will issue good quality of uniform and other PPEs as mentioned above within 30 days of taking over the contract, failing which **penalty of Rs.250/-per day per default** will be imposed till issuance of all the PPEs to the entire fireman deployed in the plant.

1.41 Contractor shall nominate /authorize senior experienced person in writing as Site incharge to co-ordinate with GIPCL Security & Fire Officer (in-charge) and who shall bear overall responsibility for performance of the contract. Such person shall remain always available at Site or Site office allotted to the contractor at Site. Contractor has to submit the authority letter and documentary proof for the same.

1.42 The Contractor shall appoint a supervisor who shall co-ordinate with GIPCL Security & Fire Officer (in-charge) for daily entrusted job. They have to maintain daily records dully signed for the works carried out and duly certified by Fire Officer (in-charge).

1.43 The Contractor in co-ordination with the GIPCL Security & Fire Officer (in-charge) shall ensure the availability of adequate manpower to carry out the job satisfactorily on a daily basis.

1.44 Contractor's supervisor will be responsible for complete supervision of the workforce engaged by him. He will be responsible for distribution of the duty posts as per requirement and arrangement for replacement of shortfall of personnel. He will also maintain all relevant records and report regularly as required under rules.

1.45 During emergency or similar situations, the Contractor shall be required to mobilize resources as per need within the period of 24 hours as directed by GIPCL. If the contractor fails to mobilize sufficient manpower to complete the job in time, GIPCL will execute the job through other agency at the risk and cost of the contractor with 10% supervision charges & the same will be recovered from the Contractor's bill.

1.46 *Important Note:* Whenever any of the Unit at Solar Park remains under outage due to any reason attributed to Security & Fire, the contractor shall mobilize sufficient work force at Site within a period of twenty-four hours from the time of intimation to the Site-in-charge or via mail to your office. Generation loss occurred due to want of manpower as well as resources will be viewed very seriously and will invite appropriate punitive measures as decided by competent authority of GIPCL.

1.47 During working in high risk area like the workman must wear a suitable safety apron, safety belt, safety hand gloves and goggles. It is the contractor's/contractor's supervisor's responsibility to ensure it without fail.

1.48 In case of fire or any other emergency or if Company receives call from OCR (Off Site Industrial Emergency Control Room) or any other Central Control and Monitoring Room, Contractor shall attend to the emergency and assist the fire crew or emergency service personnel as per the instruction of GIPCL's Authorized Officer. 1.49 All the miscellaneous activities pertaining to specific work to be executed for satisfactory performance is in the scope of Contractor in his quoted rates.

Accommodation, Food, Transportation & Miscellaneous.

1.50 The Contractor shall be responsible to make necessary arrangement for accommodation, messing, medical facility, seasonal comfort items as per the prevailing weather conditions, stationery, security equipment, uniform, accessories, sticks, torches, motorcycles for patrolling duties and any other equipment on the Site of deployment and discharge of duty needed by the security and fire safety personnel for effective discharge of their duties.

1.51 The contractor shall be responsible for providing adequate and necessary means of transportation for transporting the security and fire safety manpower to and from their place of residence to the duty station. The contractor shall also deploy suitable vehicle/vehicles for carrying out night patrolling and ensuring the security of the assets of GIPCL in the park and ensuring that no perimeter breach takes place.

1.52 The Security personnel so provided shall be the Contractor's employees, wholly under his direct administrative control and supervision and the Contractor will be held solely responsible to take disciplinary action against them (or as directed by the GIPCL management) if they indulge any act of misconduct within the premises of GIPCL or outside during the tenure of the contract. However, decision taken by GIPCL official would be final and binding on the Contractor.

1.53 Security staff deployed at SITE by Contractor must be well trained and motivated, smartly dressed and have a disciplined conduct expected of an ex-soldier. GIPCL-SITE reserves the right to reject any personnel of the Security staff and decision of the controlling officer of GIPCL about deployment of manpower shall be binding on the Contractor.

1.54 The Contractor shall intimate regarding names, addresses etc. of Security personnel deployed by him from time to time to the GIPCL's Authorized Officer. The agency will also provide detail of each security personnel to the local police station immediately on taking over the contract and on monthly basis in case of new guards deployed in GIPCL. Service Discharge Book of ex-serviceman should be submitted, which should be available for Audit as and when required.

1.55 The Contractor shall issue Identity cards to all employees engaged by him with the instruction that the same should be produced by them on demand and shall at all times be carried by them while on duty.

1.56 The Contractor shall be responsible for overall administration and discipline of the security, vigilance and fire safety staff as well as for maintenance of equipment required for efficient performance of duties as per the scope of work. One administrator in charge should be posted at the Site location, who will be responsible for leave planning and relief of security staff, provision of dress, maintenance of equipment/ motorcycles, and arrangements for daily meals. He may also assist in disbursement of wages to security staff. The Contractor will not divert security staff posted at SITE for such administrative use.

1.57 The Contractor will ensure that the Security personnel deployed at the Site are well behaved and observe discipline, good behaviour and conduct and maintain good housekeeping

as required by GIPCL. The engaged personnel shall not be found drunken or under influence of drugs while they are on duty and during their stay in GIPCL premises. They should be physically and mentally sound with good eye sight.

1.58 The Contractor shall be responsible to make necessary arrangements for proper uniform with accessories, Lathi, shoes, raincoats, gumboot, jerseys, Beet books, registers, and all other equipment needed by the security staff for performance of their duties efficiently. The Security Officer and Security Supervisors must be provided one motor cycle each with fuel and maintenance cost by the Contractor for taking rounds and reaching their duty posts in their respective areas of responsibility. Following are to be issued by the Contractor to its manpower so deployed:

1.59 The Contractor's supervisor will be responsible for proper supervision of the workforce engaged by him. He will maintain all relevant records and report regularly as required under rules or/and directed by GIPCL officials and he will coordinate with them. He will also be responsible for distribution of the duty post as directed by GIPCL official and arrangement or replacement of shortfall of force.

1.60 Contractor should maintain one computer with printer for keeping daily records' maintaining the data and preparing reports.

1.61 The Company holds the Contractor fully responsible for the security and safety of premises, assets and peoples there in the plant, colony and the mines and other area of responsibilities. The Contractor will be held liable for any thefts or security lapse that may occur during the tenure of this contract. In case of any theft or loss of money, materials and assets of the company or of the employees due to lapse/negligence of Contractor's personnel, company will deduct the same value of the amount from Contractor's dues. In this matter the decision of GIPCL will be final and binding on the Contractor.

1.62 The Contractor will provide a daily / monthly confidential report on internal and external factors and other influencing factor including data on labour union activities, if any to the HOD Security.

1.63 As provided under Contract Labour Act, payment is to be made by 7th day of every month. The penalty up to Rs.500/- for each defaulted day may be imposed. Payment received from GIPCL should not in any way be linked to the payment of wages to the security personnel.

1.64 The contractor will make arrangement to issue Salary Slip to all his employees before or on the day of disbursement of payment.

1.65 Adequate reserve will be maintained for providing weekly off to security staff.

1.66 For the shortfall in prescribed number of guards, penalty of Rs. 500/- per day will be deducted from the Contractor's monthly bill. Decision of head of Security department in this regard will be final.

1.67 All Security Supervisors should have knowledge of basic computer operation as they have to perform their duties at the gate, Pass Section / Material Section which have computerized functions.

1.68 The Contractor should provide eight security guards and two security supervisors who are specialized in crime prevention / intelligence collection.

1.69 The Contractor is required to provide two lady guards (preferably ex-Paramilitary/police) for checking the female laborers as and when demanded by GIPCL.

1.70 Standard of the Security staff should be as under:-

(i) Security Officer– Age below 55 years; should be able to read and write English and Hindi. (ii) Security Supervisor – Age below 55 years; should be able to read and write English and Hindi.

(ii) Security Guard – (Ex-Serviceman) age below 50 years; should be able to read and write English and Hindi.

(iii) The Ex-Serviceman Guards should be SHAPE-1,

(iv) Civil Guards should be below the age of 45 years with minimum 175 Cms height, he should have well-built body, free from diseases communicable or otherwise.

1.71 The Contractor may be asked to provide Dog (Doberman or Alsatian breed) Squad with two handlers as and when required at his cost & expenses. Maintenance expenses for dog will not be paid.

1.72 GIPCL reserves the right to change the norms regarding deployment of Security Guards due to exigencies of prevailing conditions. Payment to the Contractor will be made as per duty performed by actual type and number of security personnel as per quoted rates.

1.73 Any lapses/ violations by the Contractor of any of the terms and conditions, general and statutory requirements as specified in this bid document will be penalized by the controlling officer of GIPCL-SITE. Defaults like vacant post/ indiscipline/ sleeping on duty/ intoxication etc. committed by the security staff will also be penalized as decided by the controlling officer of GIPCL. Repeated defaulters shall have to be removed from Site. A cumulative penalty, as directed by GIPCL official for all lapses, violations and defaults in a month, will be imposed and deducted from the bill of the Contractor for that month.

1.74 The Contractor shall make his own arrangements for the necessary arrangement for accommodation, messing, medical facility, seasonal comfort items as per the prevailing weather conditions, stationery, security equipment, uniform, accessories, sticks, torches, motorcycles for patrolling duties and any other equipment on the Site of deployment and discharge of duty needed by the security and fire safety personnel for effective discharge of their duties.

1.75 The contractor shall be responsible for providing adequate and necessary means of transportation for transporting the security and fire safety manpower to and from their place of residence to the duty station. The contractor shall also deploy suitable vehicle/vehicles for carrying out night patrolling and ensuring the security of the the assets of GIPCL in the park and ensuring that no perimeter breach takes place.

2. <u>SPECIFIC REQUIREMENT</u>

i. The contractor will deploy adequate number of Security staff for effective and efficient security and vigilance which should include Security Officer (not below the rank JCO/equivalent), Supervisors (JCO/NCO) Equivalent rank) and Guards.

ii. The contractor shall deploy not less than 50% ex-servicemen security staff (i.e. Ex Indian Army/ Navy/ Air force/ BSF/CISF and other paramilitary /police personnel/ auxiliary force personnel/Ex-Nepal & Bhutan Army personnel) below the age of 55 years and having sound physical and mental health. Ex-servicemen's/ paramilitary personnel's original documents must be submitted to the GIPCL official at the time of initial deployment of each and every security personnel for verification and copy thereof made available for records subsequently.

iii. Remaining strength, only in Security Guards will be of Smart/good looking, experienced civilian guards with the height not less than 175 Cms. Minimum experience in security duties in Industries should not be less than 5 years. Background check of the civilian guards should be conducted by the Contractor and they should be deployed after proper police verification. Certificate in this regard will be submitted by the contractor.

iv. All Security Supervisors should have knowledge on computer operation as they have to perform their duties at the gate, Pass Section / Material Section which are computerized.

v. The contractor should provide six security guards who possess valid driving license and two security supervisors who are specialized in crime prevention / intelligence collection.

vi. The contractor is required to provide two lady guards (preferably ex-Paramilitary/police) for checking the female workers as and when required.

vii. In the event of any shortfall in the number of security guards for any reasons whatsoever it will be contractor's responsibility to replenish the requisite number of security personnel and ensure that at no moment any Site / post will be left unattended. It must be clearly understood by the Contractor that the total strength of the security staff may differ depending upon various factors. He will reduce or increase strength as desired by the GIPCL management at 24 hours' notice.

viii. The contractor may be asked to provide Dog (Doberman or Alsatian breed) Squad with two handlers as and when required. Maintenance expenses for dog will not be paid.

ix. The Security Staff so provided must be adept in providing first aid in the cases of dehydration, electric shock, snake bites, bleeding injuries, cardiac arrest etc.

x. Contractor will provide Barrack accommodation for contractor personnel. The contractor shall make his own arrangements for the meals to the Security Personnel near the plant premises in the area approved by GIPCL and will deploy one mess administrator to oversee the functioning of the mess.

xi. The Contractor shall be responsible to make necessary arrangements for proper uniform with accessories, lathi, shoes, raincoats, gumboot, jerseys, Beet books, registers, and all other equipment needed by the security staff for performance of their duties efficiently. The Security Officer and Security Supervisors must be provided one motor cycle each with fuel and maintenance cost for taking rounds and reaching their duty posts in their respective areas of responsibility.

3. FAILURE DURING EMERGENCY

During any emergencies, contractor shall have to carry out the work by deploying additional force within twenty-four hours' notice period failing which GIPCL reserves the right to carry out this work by engaging other party. The expenditure occurred due to such situations, the Contractor will be held responsible & the same will be recovered from the Contractor's monthly bill / any other pending bills along with 10% overhead charges. For repetitive failure of such work for more than two incidents, GIPCL reserve the right to terminate the entire contract by forfeiting all pending dues, Security Deposit & other retention money, if any, after giving 15 days' notice to the contractor & this will be binding to the contractor.

4. <u>SCOPE OF THE CONTRACTOR</u>

(a) Safety PPEs, as required for safe execution of work, should be arranged by the contractor.

(b) The Contractor shall have to provide necessary facilities to his workforce at his own cost.

(c) Contractor has to depute his full time experienced overall Site-in-charge for day to day work planning & coordination with Security officer in-charge, to prepare daily location wise deployment sheet, to conduct work supervision, to maintain statutory & legal compliance records, etc.

(d) The contractor's Field Officer should take round of the GIPCL's premises during the night hours, at least once in the fortnight, and submit the report in writing to the GIPCL's Authorized Officer in morning of the next day.

(e) The contractor should organize, through its qualified training officer, On the Job Training (OJT) for its guards at least once in a quarter.

5. DAILY DIARY AND PROGRESS REPORT :

A daily Duty Register will be kept in the security office. The BIDDER will supply all detailed information every day at 9:00 hours for the day preceding and the register will be jointly signed by GIPCL's officer in-charge and the BIDDER'S representative, every day in token of its correctness. Bidder's representative will similarly prepare daily Attendance Summary Sheet and obtain signature of GIPCL's officer in-charge and the Head of security. The BIDDER'S representative shall report every day to see these instructions and sign them at the bottom in token of his having seen them.

- 6. PRICE & RATES
 - (a) The rates quoted by the Bidder in the online Price Bid shall be inclusive of cost of all manpower, supervision, cost of safety supervisor, shifting, transportation, loading, unloading, equipment, safety equipment & PPEs, Rents, GST, Stamp Duties, Central or State Government or Local body or Municipal Taxes or Duties, Turn over Tax, Work Contract Tax, and / or any other duty / tax, levied by the Central, State Government or other Public bodies etc. and such other costs that are not specifically mentioned herein but will be incurred by the contractor for the satisfactory and timely completion of the work. The quoted rates shall be deemed to include for everything mentioned in the specification, all leads & lifts, contractor's overheads & profits for

due performance of the work under the contract and such other costs that are not specifically mentioned herein but will be incurred by the contractor for the satisfactory and timely completion of the work. The rates shall also include cost for mobilization / demobilization of manpower, equipment, materials, etc.

- (b) The price/rate quoted by CONTRACTOR shall be considering mobilization of all required manpower, tools & tackles, materials, equipment for timely and satisfactory completion of all scope of work.
- (c) The value and/or quantum of work may be increased or decreased depending upon day to day requirement. However, item rates remain unchanged and the payment shall be made as per the actual quantity executed as informed & certified by GIPCL officer in-charge.
- (d) The rates shall be firm for entire contract period and also during extension, if required and shall not be subject to any escalation in prices, idle charges for manpower, machinery, overhead expenses etc. except for variation in Minimum Wages rate.
- (e) Variation in Minimum Wage Rate:
 - i. GIPCL shall pay to the Bidder a lump sum rate per month plus Government Service Taxes as applicable from time to time, for carrying out the above jobs effectively & efficiently for the fulfillment of this agreement.
 - ii. GIPCL shall reimburse the PF amount based on actual manpower deployed. PF amount shall be reimbursed on actual contribution deposited and on submission of proof for the same by the Bidder.
 - iii. The increase or decrease in <u>basic rate</u> as per Minimum Wage Act by the Government will be calculated and effect will be given with effective date as per Government notification.

- iv. The increase or decrease in <u>Special Allowances(if applicable)</u> as per Minimum Wage Act notified by the Government will be reimbursed separately at the end of Month period on actual basis, subject to successful compliance of all obligations under the Contract.
- v. Minimum Wage Rates prevailing during 01/10/2024 to 31/03/2025 will be the benchmark rates for the purpose of calculating the said increase or decrease, as stated at clauses (c) and (d) above.

7. <u>CONTRACT PERIOD</u>

Contract period will two years from the date of issue of LoI or Work Order whichever is earlier. Mobilization period will be 07 to 15 days from the date of issue of LoI or Work Order, whichever earlier.

8. TERMS OF PAYMENT

The contractor shall raise the location wise separate running invoices in duplicate every month in respect of the work performed or completed during the month along with the documents as hereinafter provided. On receipt of the invoice complete in all respects and with all the said documents, the payment in respect of the same shall be made within 21 days of such receipt of a complete invoice as per the following terms of payment:

- a) 100% of monthly RA bill along with 100% taxes shall be released against the work executed duly certified by GIPCL. Income Tax (IT) will be deducted at source from monthly RA bills as per the rules in force.
- b) Security deposit at 10% of Annual contract value excluding taxes & duties shall be submitted as per clause no.: 1 of Section-C.
- c) GST shall be paid along with bills after fulfilment of following terms:
 - (i) Submission of copy of registration certificate issued by GST Authority (to be furnished only once).
 - (ii) Citing the Goods and service Tax Registration no. and the date of issue of registration certificate on invoices.
 - (iii) Claim of GST amount with percentage (%) separately shown on the invoices.
 - (iv) The contractor shall be required to submit the proof of payment of GST of previous month/quarter, as may be applicable as & when demanded by GIPCL/Owner/company.
 - (v) The Bidder shall inform the GIPCL in the event of cancellation of its registration certificate cancelled or discontinued for whatsoever reason.
- d) The Contractor shall furnish the checklist as per ANNEXURE-A enclosed with the Section-F of tender document along with the RA bill of respective month.
- e) While making running account payment, the following deductions may be made by GIPCL, if applicable:
 - (i) Cost of material issued, if any, by GIPCL & to the extent consumed in the work.

- (ii) Security deposit recoverable if any.
- (iii) Advance on materials / work progress advance payments, if any.
- (iv) LD/Penalty for delayed delivery, penalty for delayed execution of work, recovery of charges for the work done by other contractor due to delay or any other reason, if applicable
- (v) Any other dues recoverable by GIPCL from the contractor under the contract.
- f) The contractor along with monthly RA Bill shall submit copy of P.F. Challan, wages register of previous month, attendance sheet of respective month & ECR statement indicating the employee and employer's P.F contribution of previous month with respect of employees employed by him for the contract at GIPCL Site.
- g) The Contractor shall submit his Final Bill within a period of four months of the expiration or earlier termination of the contract or any extensions that may be granted by GIPCL to the Contractor. GIPCL shall not entertain any bill for any work item after expiration of period of four months.
- h) The Contractor shall include all his claims in the Final Bill submitted by him and accordingly the final bill submitted by the Contractor shall be deemed to be inclusive of all and whatsoever the claims that the Contractor may have from GIPCL. The Contractor shall not be entitled to claim any amounts which are not mentioned in the Final Bill and the Contractor shall be deemed to have waived any claims not mentioned in the Final Bill and shall not be entitled to recover the same from GIPCL subsequent to the submission of the Final Bill on any account and GIPCL shall stand absolved of all its liabilities in respect of any such claims not raised by the Contractor in his Final Bill.

9. SUBMISSION OF STATUTORY COMPLIANCES WITH EACH BILL

Contractor shall submit each RA bill of work carried out along with following documents.

- (i) Copy of statutory compliance like Labour License, Wages Payment Register, EC Policy, PF paid Challan with ECR, etc... along wage certificate pertaining to respective bill period. (ii) Notarized Indemnity Bond as per Performa, in case of Final bill.
- (ii) No claim No arbitration certificate as per Performa, after releasing final bill payment.

Bill submitted without any of the above documents shall not be processed for payment.

10. MOBILIZATION AND EXECUTION

- a) Contractor shall mobilize the resources at Site within 7 to 15 days from the time the intimation given by GIPCL.
- b) Contractor shall provide required separate & independent Site supervisors who will be responsible for supervision and execution of job in specified time with respect to quality, specifications, Site preparations, safety, co-ordination with GIPCL, issue of work permits, joint measurements, etc... The supervisors shall coordinate with the Security Officer in charge of GIPCL for proper execution of the job.

c) The resources required for execution of work detailed in the Scope of Work will vary from time to time. Hence, contractor shall mobilize the resources accordingly.

11. QUANTITY OF WORK

The estimated quantities of work required to be carried out by the contractor are as given in the Section-E (Schedule of Quantity) estimated and shall vary according to the exigencies of work at Site. However, the rates quoted by Bidder shall remain firm irrespective of any variation in estimated quantities. Contractors shall engage required nos. of guards along with required tools & tackles as per work load and emergency situations throughout the contract period to perform his contractual duties.

In case, contract quantity/amount gets exhausted before completion of contract period, GIPCL reserve the rights to increase the quantities or contract amount for successful completion of work for the entire contract period. Contractor shall be responsible to complete the particular job up to entire satisfaction of security officer in-charge. The item rates remain firm & unchanged till completion of the contract and any agreed extensions thereafter and shall not be subject to any escalation, idle charges for labor, machinery, overhead expenses etc. for any reason whatsoever. The quantum of work of individual item may be up to any extent depending upon requirement. However, item rate remains unchanged. Under this contract, contractor has to execute all work as per the Plant requirement.

12. GENERAL CONDITIONS OF CONTRACT

General Conditions of Contract (Section-C) and detail specification prepared by GIPCL will be applicable for this contract. The same is enclosed herewith. Bidders are advised to go through the same.

Where any portion of the general conditions of contract is repugnant to or at variance with any provisions of the special conditions of contract, then unless a different intention appears, the provision of the special conditions of contract shall prevail to the extent of such repugnancy of variance.
