CORRIGENDUM - I

The following changes are made in the relevant clauses of the tender document:

1. Clause No. 4.1.1 at Page No. 37 is amended as below: -

Clause No. 4.1.1: Bidder should possess experience in similar nature of jobs like any type of earth excavation in Mines, overburden removal and mining of Coal/ Lignite using hydraulic shovels/ excavator with matching dumpers or surface miners and should enclose proof of the same. Bidder shall submit necessary evidence for the same like attested copies of work orders along with work completion certificates from clients. The work completion certificate shall comprise of executed quantity in CuM/Tonne. Bidders should have executed the work directly.

The experience should be either of the following:

- a. Bidder should have executed the work, from one single order or from one single mine, of at least 162.00 Lakh CuM aggregate of OB/IB and Coal/ Lignite, out of which there should be minimum 25.00 Lakh Te of Coal/ Lignite, in any of the last three financial years (2015-16, 2016-17 and 2017-18) or
- b. Bidder should have executed the work, from two orders each or from two single mines each, of at least 102.00 Lakh CuM aggregate of OB/IB and Coal/ Lignite, out of which there should be minimum 16.00 Lakh Te of Coal/ Lignite, in any of the last three financial years (2015-16, 2016-17 and 2017-18) or
- c. Bidder should have executed the work, from three orders each or from three single mines each, of at least 81.00 Lakh CuM aggregate of OB/IB and Coal/ Lignite, out of which there should be minimum 13.00 Lakh Te of Coal/ Lignite, in any of the last three financial years (2015-16, 2016-17 and 2017-18).

Experience taken in the capacity of sub contractor shall also be considered provided experience certificate is issued, by the main company, for which the contract work is carried out, in the name of sub contractor.

Note: - For conversion 1.00 CuM of lignite should be taken as 1.16 Te of Lignite and 1.00 CuM of coal to be taken as 1.4 Te of Coal.

2. Clause No. 4.4 at Page No. 38: - It is clarified that the bidder is allowed to submit an undertaking that he will procure and commission the Lignite Handling System with appropriate capacity of feeder breaker or Mobile feeder breaker or other mechanical means before commencement of lignite supply as per schedule envisaged in the tender document. It is further clarified that no extension of development period on this account will be granted by GIPCL.
